

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON **DECEMBER 5, 2006**

CALL TO ORDER: Village President John Schmitt brought the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

PLEDGE TO FLAG: Village Clerk Kautz led all present in the Pledge of Allegiance.

ADOPT AGENDA: Moved by Smith, seconded by Read, to adopt tonight's agenda as printed deleting item 15, Executive session.

COMMITTEE & CLERK'S REPORTS:

<u>COMMITTEE OF THE WHOLE</u> ~ Trustee Read reported on minutes from the November 28 Committee meeting. The minutes are available for review at Village Hall. Items on tonight's Omnibus Agenda were among those discussed at the Committee. The following action is required at this time.

Under Community Development

1. Moved by Read, seconded by Smith, to pass <u>ORDINANCE 2006-O-68,</u>
<u>APPROVING A FINAL PLAT OF SUBDIVISION AND A FINAL PLANNED</u>
DEVELOPMENT FOR TWO CONDOMINIUM BUILDINGS (MAIN STREET COMMONS)

During discussion, Trustees Spella and Glogowski asked about what type of television reception would be used, and voiced concern about the placement of satellite dishes. Mr. Mihelich responded that the Village can not restrict either type of use but would have conversations with the developer regarding the limiting the number of dishes to be used.

(Regarding the roll call vote, Trustee Steigert, who recused himself from all past committee discussions involving this project, will abstain. In addition, President Schmitt wanted his vote to be taken.)

Roll call vote; voting aye -- Read, Smith, Dianis, President Schmitt. Voting nay -- Spella, Glogowski. Abstaining -- Steigert. Motion carried; 4-ayes, 2-nays, 1-abstention.

VILLAGE CLERK ~ Clerk Kautz announced upcoming scheduled Village meetings.

STAFF REPORTS:

VILLAGE MANAGER ~ Mr. Ganek reported the following:

1 - He will defer comments regarding today's Wastewater Treatment Plant failure to Mr. Mitchard, but he took time to thank all of Staff for their efforts and quick response.

PUBLIC WORKS DIRECTOR ~ Mr. Mitchard reported the following:

1 - He presented a time line of events for this morning's Wastewater Treatment Plant (WWTP) membrane failure at the Dystor Gas Collection System Digester #1. A spill of partially treated anaerobic sludge, about 10,000 gallons was contained in an area that is under development as a parking lot. There were no injuries, and no threat to the public or village residents. No bio-solids from the WWTP entered the Fox River or drinking water system. Staff responded with emergency plan procedures, and the other digester can handle the load until repairs are completed. Village insurance should cover most of the cost of repairs. 2 - The recent snow storm caused hard packing on the roads and streets. Staff is correcting and adjusting equipment to keep the ice from causing problems in the future. 3 - Any mail boxes damaged by the Village will be replaced with a standard box and post which is valued at \$45. 4 - His staff is working on the new budget and also involved in recruitments.

COMMUNITY PLANNING DIRECTOR ~ Mr. Mihelich reported the following:

1 - The Ted Spella Leadership class traveled to the McHenry County Jail to study criminal procedures and toured the facility. 2 - A new Arby's restaurant will be built on Randall Road, and the Kobe Japanese Restaurant opened last week. 3 - Commercial development is increasing on South Main Street.

VILLAGE ENGINEER ~ Mr. Cuda reported the following:

1 - The Circle Drive Ravine project bid opening will take place next Tuesday. 2 - His staff is working on new project reviews.

POLICE DEPARTMENT ~ Chief Laine reported the following:

1 - His staff has been involved with budget preparation and recruitment of new officers. 2 - The next D.A.R.E. graduation will be held at Westfield School this coming Friday. 3 - The
