

# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, ILLINOIS HELD IN VILLAGE HALL ON APRIL 17, 2012

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll.

ROLL CALL: Present: Trustees Brian Dianis, Debby Sosine, Robert Smith, Jerry Glogowski, Jim Steigert, John Spella. A quorum was established. Staff in attendance: Bill Ganek, Village Manager; Russ Farnum, Director of Community Development; Bob Mitchard, Director of Public Works; Steve Kuzynowski, Parks & Forestry Supervisor. PLEDGE TO FLAG: Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Dianis, to adopt tonight's agenda moving Item 7C-3 to Item 8, Discussion of Omnibus Agenda items, and deleting Item 15, Executive Session. Voice vote: ayes carried.

Moved by Steigert, seconded by Sosine, to approve the Omnibus Agenda of April 17, 2012. Roll call vote; voting aye – Steigert, Glogowski, Smith, Sosine, Dianis, Spella. Motion carried; 6-ayes, 0-nays.

#### ITEM REMOVED FROM OMNIBUS:

Moved by Steigert, seconded by Glogowski, to approve an Intergovernmental Agreement with IDOT for the Jurisdictional Transfer of Main Street and the Construction of the Algonquin Western Bypass subject to the mutually agreed resolution of the Village Tree Preservation Ordinance as stated in the 4(f) Study.

During discussion, Mr. Ganek explained that two outstanding issues were now clarified-one being the right-of-way transfer of the land beneath the road that occurs after the jurisdictional transfer with the state agreeing to the language, and the second issue the state agreeing to the Village Tree Preservation Ordinance as stated in the 4(f) Environmental Study approved several years ago.

Roll call vote: voting aye - Steigert, Smith, Spella, Sosine, Dianis, Glogowski. Motion carried: 6-ayes, 0-nays.

Moved by Dianis, seconded by Sosine, to approve the List of Bills for payment dated 04/17/12 and Payroll dated 04/15/12 in the combined amount of \$661,451.55 as recommended. Roll call vote: voting aye - Dianis, Glogowski, Steigert, Smith, Spella, Sosine. Motion carried: 6-ayes, 0-nays.
