<u>COMMITTEE OF THE WHOLE</u> ~ Trustee Glogowski reported the Committee met April 24, 2012 with minutes now on file. Items were acted upon on the Omnibus Agenda. The following Board action is required at this time.

Moved by Glogowski, seconded by Sosine, to accept the low bid and award the contract for the Lawndale Park Creek Streambank Stabilization to EnCap, Inc. of Sycamore, Illinois in the amount of \$89,078.44. Roll call vote: voting aye – Glogowski, Steigert, Smith, Spella, Sosine, Dianis. Motion carried 6-aye, 0-nays.

STAFF REPORTS:

VILLAGE MANAGER ~ Mr. Ganek reported the following:

1- Village e-Waste collection will be next Saturday from 9 a.m. to 1 p.m. 2- Pool class signup started today. 3- The Annual Budget is now on the web site for viewing. 4- The Recreation Department's "Run for Rec" 10-mile race will be held May 19. So far 50 entrants have signed up. 5- Founders' Days Parade alternatives will be discussed at the next Committee of the Whole. The Founders' Committee will be present. 6- Indian Grove improvements will be on the Committee of the Whole agenda of May 8. Some redesign will be needed. If funds are not used for that project, it could be possible to use them for Spring Creek Section 3 and which could then be finished this year.

PUBLIC WORKS ~ Mr. Mitchard reported the following:

1- Various design issues are being reviewed by staff regarding the Indian Grove Subdivision improvements. 2- Edgewood tree removal is completed and NICOR is now on site. 3- Riverside Plaza pre-con meeting was held today. 4- Spring Creek Farms Section 2 work is underway along with work in the Glenmoor Subdivision. 5- Parkway tree planting continues throughout the Village, and the public rights-of-way mowing service contracts are completed. 6- Hydrant flushing is taking place on the west side of the Village. Any discoloring of water will subside.

<u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported the following:

1- Rain barrels are still available until this Friday with delivery on May 10. 2- The Eco Committee has produced a pocket-size Bike Path Route Booklet that can be picked up in the lobby of Village Hall. McHenry and Kane County "green" guides are also available.

<u>POLICE DEPARTMENT</u> ~ Chief Laine reported the following:

1- Two alternatives for the Founders' Days Parade are on the table with all issues to be discussed. 2- The Prescription Drug Take-Back Program was completed with about 50 pounds of drugs collected. 3- DARE graduations will be May 18 at Eastview Elementary School and May 21 at Neubert. 4- The McHenry County Bar Association has recognized Sergeant Brett Wisnauski for his outstanding work in combating domestic violence. Congratulations. 5- The "Battle of the Badges" Basketball Game, Algonquin police versus Lake in the Hills police, will take place May 12 at Jacobs High School. All are invited to attend with donations going to Special Olympics.
