# **Utilities Superintendent Named Operator of the Year**

Andy Warmus, Utilities Superintendent for the Village of Algonquin, was named Operator of the Year in April by the Illinois Association of Water Pollution Control Operators (IAW-PCO). "Andy's contributions to the operations at the Wastewater Treatment Facility have allowed the Village to become an industry leader and a model for other communities," said Village President John Schmitt. "We're proud to have top-caliber staff such as Andy providing services to Village residents and businesses."

Award nominations are submitted by the IEPA while the awards inspection process is conducted by IAWPCO members. There are approximately 5,000 certified wastewater operators in Illinois; all are eligible to be nominated for this award. The purpose of the Illinois Association of Water Pollution Control Operators is to bring together wastewater treatment professionals to educate, encourage the exchange of ideas, and exhibit the latest equipment and technologies. ## **Every Drop Counts - Water Conservation Regulations**

In May, Village staff visited local elementary schools where students learned the importance of water conservation and how to save water. Simple ideas for saving water include: cover your swimming pool when not using it, do only full loads of dishes/clothes, turn off water when brushing your teeth, water landscaping early morning or at night, use a rain barrel, set your mower blades higher and fix leaks right away. The Village reminds you that summer watering restrictions are in place. To check current water system status, see signs posted on primary streets in the Village, call Village Hall 847-658-2700, or look on the Village's website www.algonquin.org.



**CONSERVATION:** *Green* signs indicate outside water use is permitted except for watering landscaping and lawns which is prohibited between the hours of 9:00 a.m. and 6:00 p.m.

**EVEN/ODD:** Yellow signs indicate even/odd days for watering before 9:00 a.m. and after 6:00 p.m. Even addresses may only water on even calendar days, and odd addresses may only water on odd calendar days before 9:00 a.m. and after 6:00 p.m. **EVEN/ODD 6:00-9:00 A.M.:** Orange signs indicate even/odd days for watering only between the hours of 6:00 a.m. and 9:00 a.m. Even addresses may only water on even calendar days, and odd addresses may only water on odd calendar days from 6:00 a.m. to 9:00 a.m.

**RESTRICTED:** *Red* signs indicate no outside water use is allowed at any time. This includes all use of water outside, such as washing vehicles, power washing, and watering landscaping.

### **Construction Info**

Following are a few of the major construction projects happening in Algonquin this summer:

**Western Bypass (IL Route 31):** Work has begun on site grading and excavation activities on the proposed route from Algonquin Road north to Main Street. The grading work is expected to be completed in November 2012.

**Edgewood Drive:** This project includes the complete reconstruction of Edgewood Drive between Hanson Road and Main Street, bridge replacement, and path construction. Traffic on Edgewood Drive is restricted with Algonquin Road as the designated detour route. Work is expected to be completed in 2013.

**Spring Creek Farms Subdivision:** Project consists of roadway resurfacing and repair of curbs, aprons, and sidewalks with expected completion in Fall 2012.
