

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, ILLINOIS HELD IN VILLAGE HALL ON MAY 15. 2012

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll.

PLEDGE TO FLAG: Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Dianis, to adopt tonight's agenda including Item 16, Executive Session--pending litigation. Voice vote: ayes carried.

<u>PRESENTATION</u>: Ms. Parkhurst announced the winners of the Environmental Gold Leaf Awards. The recipients for this year are the Huntley Fire Protection District for newly constructed Station Number 4 located just west of Square Barn Road; Eastview Elementary School Earth Club as the club meets monthly after school to work on environmental projects such as recycling programs, trash cleanup, and working on the school's prairie and woodlands; and the Kanner residence for converting their typical turf grass yard into a yard planted with native plants that create a livable habitat for our native birds, insects, and animals.

1- The May 5 e-waste recycling event was very successful with over 575 vehicles dropping off many items. Another event will be scheduled in October. 2- The "Run for Rec" race will be conducted this Saturday. 3- The swimming pool opens May 26.

<u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported the following:

1- Rain barrel and composter sales have gone well and made \$500 for the ECO Committee projects. 2-The Leadership School is having an open house for those who may be interested in attending. It will be held May 24 at the Chamber of Commerce office.

<u>PUBLIC WORKS</u> ~ Mr. Mitchard reported the following:

1- Edgewood Road reconstruction project is ongoing with bridge work being held up pending state approval of plans. All other installations are going well. 2- Spring Creek Section 2 concrete work continues. 3- Indian Grove is being redesigned to adjust the road for more trees. Bids will be done in January. 4- Bids for Spring Creek Phase 3 will be May 31. 5- Tree planting throughout the Village is ongoing. Staff is very busy with this project. 6- Glenmoor Subdivision road repairs are taking place. 7- They are working on the Water System Master Plan. 8- The Riverside Plaza storm sewer overflow work is to proceed.

POLICE DEPARTMENT ~ Deputy Chief Urban reported the following:

1- DARE graduations are forthcoming at local schools; all are invited. 2- Police Officer Memorial day is taking place today in Springfield with officers from our department participating in the event.
