

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, ILLINOIS HELD IN VILLAGE HALL ON JUNE 5. 2012

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:32 p.m. Village Clerk Jerry Kautz called the roll.

ROLL CALL: Present: Trustees Debby Sosine, Robert Smith, Jerry Glogowski, Jim Steigert, John Spella, Brian Dianis. A quorum was established. Staff in attendance: Bill Ganek, Village Manager; Russ Farnum, Director of Community Development; Bob Mitchard, Director of Public Works; Russ Laine, Chief of Police. Attorney: Kelly Cahill was also present.

PLEDGE TO FLAG: Boy Scouts from Troop 368 led all present in the Pledge of Allegiance.

COMMITTEE & CLERK'S REPORTS:

<u>COMMITTEE OF THE WHOLE</u> ~ Trustee Steigert reported the Committee met on May 2 with most items being on tonight's Omnibus Agenda. The following board action is required at this time:

Under Public Works & Safety

Motion to Award Bid for Asphalt Material Purchases for 2012 Using MFT Funds

(1) Moved by Steigert, seconded by Sosine, to award the annual material purchase contract to Arrow Road Construction of Mount Prospect and authorize the use of MFT Funds for the total annual cost for the surface asphalt bid \$78,030 and \$28,750 for binder asphalt. Roll call vote: voting aye – Steigert, Glogowski, Smith, Sosine, Spella, Dianis. Motion carried: 6-ayes, 0-nays.

<u>VILLAGE CLERK</u> ~ Clerk Kautz reported future meetings of Boards and Commissions.

STAFF REPORTS:

ADMINISTRATION ~ Mr. Ganek reported the following:

1- The "Run for Rec" event went very well with the winner of the 10 miles coming in at a little over an hour. 2- Sales of swimming pool passes have increased 11 percent over last year. 3- The village's Facebook account has been very successful.

COMMUNITY DEVELOPMENT ~ Mr. Farnum reported the following:

1- Two restaurants recently opened in Algonquin. 2- Algonquin Antiques ribbon cutting will be this Friday.

PUBLIC WORKS ~ Mr. Mitchard reported the following construction updates:

1- Grading of the western bypass is well underway with tree removal. 2- Riverside Plaza sidewalk and curb work are going well. 3- The storm sewer on North Harrison Street is ahead of schedule. 4- Edgewood Drive storm sewers are being installed, but AT&T utilities are a problem and the company is not cooperating. 5- Spring Creek Phase 2 street binder is being installed and almost completed to be followed by landscape. Phase 3 bids are below engineer estimates and will be discussed at the next Committee of the Whole. 6- The design changes for the Indian Grove Subdivision are going well and should be ready for bidding this winter when bid prices are favorable.

<u>POLICE DEPARTMENT</u> ~ Chief Laine reported the following:

1- The Torch Run for Special Olympics will start in Barrington this Sunday, with the runners expected in Algonquin around 8:30 a.m. 2- Founders' Days Parade plans are ongoing. 3- Two tobacco compliance checks were recently performed with only one establishment failing. They will be in Municipal Court. There were also three liquor violations from a recent compliance check with those coming before the Liquor Commission in the near future.

<u>VILLAGE ATTORNEY</u> ~ Ms. Cahill reported the following:

1- Her office has been involved with ongoing litigation, public works issues, and review of agreements.

CORRESPONDENCE & MISCELLANEOUS:

- 1. Messrs. Schmitt and Glogowski will be traveling to Colorado on Thursday to view a CFI intersection that is very similar to the one proposed at Randall and Algonquin Roads.
- 2. A proclamation will be signed to enact water conservation measures from green to yellow status effective June 13, 2012.

NEW BUSINESS:

The Lake in the Hills Historical Society wishes to move the historic Ford schoolhouse from the current property in Algonquin to a location in Lake in the Hills. It requires a moving permit, so the not-for-profit Historical Society is asking for a waiver of permit fee.

(1) Moved by Steigert, seconded by Glogowski, to waive the building moving fee for the Lake in the Hills Historical Society. Voice vote: ayes carried
