1. Moved by Ritt, seconded by Steigert, to authorize the Village Treasurer to release the school developer donation funds to School District 300 in the amount of \$934,044.64 for improvements identified in the District's correspondence of January 20,2000.

Motion carried; 5-ayes, 0-nays, 1-absent.

2. Moved by Steigert, seconded by Smith, to reduce the building permit internal inspection fee for the reconstruction of the St. John Evangelical Lutheran Church by 75% provided that all fees and costs incurred by the Village in the course of such inspections from external consultants shall be paid in full.

Roll call vote; voting aye -- Steigert, Wolski, Smith, Schmitt, President Spella. Motion carried; 4-ayes, 0-nays, 2-absent.

Trustee Ritt returned to the meeting and was seated at 8:19 P.M.

<u>PLANNING</u>, <u>BUILDING & ZONING</u> ~ Trustee Schmitt reported his committee has not met since the last Board meeting.

<u>PUBLIC WORKS</u> ~ Trustee Smith reported his committee met 2/3/00 with minutes forthcoming. The following action is required tonight.

- 1. Moved by Smith, seconded by Schmitt, to reject all bids received for the Riverfront Park construction, and authorize Staff to re-bid the project with possible cost savings adjustments. Roll call vote; voting aye Smith, Schmitt, Ritt, Steigert, Wolski. Motion carried; 5-ayes, 0-nays, 1-absent.
- 2. Moved by Smith, seconded by Schmitt, to accept the lowest bid for proposal number one, and award the contract for the painting of the Cary Road Water Storage Standpipe to Thomas Industrial in the amount of \$75,703.00

Roll call vote; voting aye – Smith, Schmitt, Ritt, Steigert, Wolski.

Motion carried; 5-ayes, 0-nays, 1-absent.

3. Moved by Smith, seconded by Schmitt, to accept the lowest bid for proposal number four, and award the contract for painting of the Route 62/Countryside Water Storage Standpipe to Telcorp, Inc. in the amount of \$132,600.00

<u>PUBLIC HEALTH & SAFETY</u> ~ Trustee Wolski reported her committee has not met since the last Board meeting

At this time, President Spella presented Mr. Avelar with a plaque of appreciation and thanked him for the past three years of service to the Village of Algonquin.

2. Trustee Smith requested, through the Finance Committee, a discussion of drawing back the utility tax as a tax relief in wake of the anticipated sales tax from the new businesses in town. President Spella warned that a study is needed to determine how the retail taxes from new businesses will benefit the Village. Staff will have all officials review the Utility Tax Ordinance and how it pays for Village infrastructure.
