MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON JULY 18, 2000

<u>CALL TO ORDER</u>: Village President Ted Spella called the regular meeting to order at 8:00 PM. In the absence of Village Clerk Jerry Kautz and Deputy Village Clerk Jenna Kollings, Trustee Schmitt moved and Trustee Steigert seconded a motion to appoint Jeff Mihelich as Acting Village Clerk for the July 18, 2000 Village Board meeting. Voice vote; ayes carried.

ROLL CALL: Present: President Spella. Trustees: Jim Steigert, Robert Smith, John Schmitt, Linda Wolski. Absent: Lorraine Ritt and Constance Donner. There was a quorum.

Staff in attendance: Administration: William Ganek, Jeff Mihelich, Robert Mitchard, and Russell Laine. Attorney - H. D. Rogers, Engineer - Frank Cuda.

<u>PLEDGE TO FLAG</u>: President Spella asked Jeff Mihelich to lead all present in the pledge of allegiance.

<u>ADOPT AGENDA</u>: Moved by Schmitt, seconded by Steigert, to adopt tonight's agenda as printed deleting Item 14 "Executive Session". Voice vote; ayes carried.

AUDIENCE PARTICIPATION:

Charles Stasny, 302 River Bluff Drive, Carpentersville, Illinois 60110, expressed his concerns regarding the display of United States Flags on Village of Algonquin property, and other properties in the Village. Mr. Stasny also read a statement regarding the importance of the American flag and what it represents. Village Manager Ganek responded that all United States flags that are flown on Village property are displayed correctly and noted that if any flags become tattered, or luminaries are dysfunctional, corrective action occurs immediately.

COMMITTEE & CLERK'S REPORTS:

<u>PUBLIC WORKS & SAFETY</u> ~ Trustee Smith reported his committee discussed the addition of a stop intersection at Tenby Way and Whitehall Lane, the designation of a 25 miles per hour speed limit on Oceola Drive, the allocation of MFT funds for Phase I & II Engineering for Huntington/Harnish Drive resurfacing, and Public Works Department surplus equipment, with the items noted above being approved during the omnibus agenda.

Trustee Smith also described the following projects, with the Board voting to award the bids as follows:

Trustee Smith moved, and Trustee Wolski seconded a motion to award the Arbor Hills Subdivision Pressure Reducing Valves project to Gluth Brothers Construction, Incorporated in the amount of \$57,360.

Roll call vote; voting aye – Trustees Steigert, Smith, Schmitt and Wolski.

Motion carried; 4-ayes, 0-nays, and 2-absent.

Trustee Smith moved, and Trustee Wolski seconded a motion to award the Water Treatment Plant #1 roof repair project to Riddiford Roofing in the amount of \$23,242.

Roll call vote; voting aye – Trustees Steigert, Smith, Schmitt and Wolski.

Motion carried; 4-ayes, 0-nays, and 2-absent.

Trustee Smith moved, and Trustee Wolski seconded a motion to award the Fieldcrest Farms Drainage Improvements project, including the elimination of project improvement items 7, 8 and 10 to Tim's Excavating in the amount of \$71,921.15.

Roll call vote; voting aye – Trustees Steigert, Smith, Schmitt and Wolski.

Motion carried; 4-ayes, 0-nays, and 2-absent.

<u>GENERAL ADMINISTRATION</u> ~ Trustee Steigert reported his committee has not met since the last Board meeting.

<u>COMMUNITY DEVELOPMENT COMMITTEE</u> ~ Trustee Schmitt reported his committee has not met since the last Board meeting.

<u>COMMITTEE OF THE WHOLE</u> ~ President Spella reported that the Committee of the Whole met on July 13th and discussed the Final Draft Downtown Revitalization Plan. President Spella also noted that the August Committee of the Whole meeting will include a presentation from McHenry County and its consultants regarding the Western Bypass project.

STAFF REPORTS:

<u>VILLAGE MANAGER</u> \sim Mr. Ganek reported that the Merrill-Pioneer Park dedication ceremony is scheduled for August 12th at 9:00 a.m.

<u>PUBLIC WORKS DIRECTOR</u> ~ Mr. Mitchard reported that his department is filling vacant positions, they had a pre-construction meeting for the Algonquin Lakes project, he reported on the status of the route 31/62 right turn lane improvements, his crews are preparing for the Founder's Day events, they are reviewing plans for various infrastructure improvement projects, and they are beginning to review a draft collective bargaining agreement.

<u>VILLAGE ENGINEER</u> ~ Mr. Cuda reported that there will be a bid opening on July 28th, and he then provided status reports on the Janak's Phase IV final lift, Harper Drive Box Culvert, and the Riverwoods Drive projects.

POLICE CHIEF ~ Chief Laine reported that the Police Department will offer child safety seat inspections at Founder's Days, they will have a "set belt convincer" display available, they are working on the at-risk children PAT camp, and various traffic studies.

<u>COMMUNITY DEVELOPMENT DIRECTOR</u> ~ Mr. Mihelich reported that his department is working on plan reviews, retail and business park marketing efforts, and grants implementation. In absence of the Village Clerk, Mr. Mihelich also read the list of Village meetings through the next Village Board meeting.

<u>VILLAGE ATTORNEY</u> ~ Mr. Rogers reported that he and his staff have been working on various development matters, land acquisition and personnel matters.
