MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON FEBRUARY 6, 2001

CALL TO ORDER: Village President Ted Spella called the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

ROLL CALL: Present; Trustees, Jim Steigert, Bob Smith, Constance Donner, John Schmitt, Linda Wolski, Barbara Read. A quorum was established.

Staff in attendance; Administration – William Ganek, Bob Mitchard, Jeff Mihelich, Russell Laine. Attorney – David Rogers, Engineer – Frank Cuda.

PLEDGE TO FLAG: Eddie Zordani, Scout Troop 155, led all present in the Pledge of Allegiance.

ADOPT AGENDA: Moved by Schmitt, seconded by Wolski, to adopt tonight's agenda as printed deleting item 14, Executive Session, and adding item 4A Proclamation. Voice vote; ayes carried.

PROCLAMATION: Clerk Kautz read a proclamation stating the week of February 19 to 23, 2001 as "Autism Awareness Week" in Algonquin.

AUDIENCE PARTICIPATION:

- 1. Patrick Colcernian, 1011 Glacier Parkway, Algonquin, addressed the Board regarding the following issues:
 - a. Voiced concern about utility taxes and thanked the Board for suspending the natural Gas Tax for the next 90 days.
 - b. Concerned about 1.97 acres that had to be given to Kane County and getting .3 of an acre in return due to an error when building the new lift station. He asked the Board to consider a change of engineering firms when appointments are made in April.
 - c. He is upset with the advertisement papers being strewn about the neighborhoods without consent of the property owners. The Village Attorney, Rogers, explained that these papers have just enough news in them to classify as a newspaper and under the Constitution cannot be stopped unless the individual property owner sends a letter to the publisher. If their carrier litters the streets, then the publisher or carrier can be fined.
 - d. Concerned about the Boundary Agreement with Barrington Hills as he wants a section to be protected from development and have it given to the Village of Barrington Hills. (The Board approved the Agreement as drafted)

As of February 1, the Village's Fire Rating was upgraded with a classification of 4. This could result in lower property insurance for those within the Village limits.
