# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON FEBRUARY 20, 2001

<u>CALL TO ORDER</u>: Village President Ted Spella called the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

**ROLL CALL:** Present; Trustees, Jim Steigert, Bob Smith, Constance Donner, John Schmitt, Linda Wolski, Barbara Read. A quorum was established.

Staff in attendance; Administration – William Ganek, Bob Mitchard, Jeff Mihelich, Russell Laine. Attorney – David Rogers, Engineer – Frank Cuda.

**PLEDGE TO FLAG:** Clerk Kautz led all present in the Pledge of Allegiance.

**ADOPT AGENDA:** Moved by Schmitt, seconded by Wolski, to adopt tonight's agenda as printed deleting item 14, Executive Session.

#### **AUDIENCE PARTICIPATION:**

Phillip Robertson, 8 Joseph Court, Lake in the Hills, stated he was a member of the LITH Plan Commission and was concerned both as a member and also living on the parameter of the Meyer Material property. He said there is equipment being put in place that does not look like mining equipment. Mr. Ganek stated he would have an inspector investigate, as only mining should take place until the property is ready for reclamation. The property, which is part of Algonquin, is zoned as industrial and the final use will have to be approved by the Village at the time of future development and no discussions with Meyer have taken place to date. Mr. Robertson suggested that both Villages get together in the future to discuss the property use.
