MINUTES OF THE REGULAR MEETING

OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON APRIL 17, 2001

<u>CALL TO ORDER</u>: Village President Ted Spella called the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

ROLL CALL: Present; Trustees, Jim Steigert, Bob Smith, Constance Donner, John Schmitt, Barbara Read. Absent; Linda Wolski. A quorum was established. Staff in attendance; Administration – William Ganek, Bob Mitchard, Jeff Mihelich, Russell Laine. Attorney – David Rogers, Engineer – Frank Cuda.

PLEDGE TO FLAG: Clerk Kautz led all present in the Pledge of Allegiance.

ADOPT AGENDA: Moved by Schmitt, seconded by Smith, to adopt tonight's agenda as printed deleting item 15, Executive Session.

Voice vote; ayes carried.

PROCLAMATIONS: Clerk Kautz read a proclamation proclaiming Arbor Day in Algonquin, April 27, 2001. President Spella read another proclamation naming the week of April 29 to May 5, 2001 as Municipal Clerks Week in Algonquin and he extended his appreciation to Jerry Kautz for his service to the community as Village Clerk.

- 1. Richard Schnell, 3570 Bunker Hill Drive, Algonquin, requested that a special water meter be installed at his home for the water use in lawn care as he said the run off goes back into the ground. Mr. Mitchard replied that the water rates in the Village are based on both water and sewer and are the most affordable in the area as the lower costs offset the need for separate meters. Mr. Ganek added, this system is the most fair and equitable for all Village residents.
- 2. Greg Haluczak, 711 majestic, Algonquin, thanked the Board for their efforts in getting Realen Builders to repair defects in their homes but said the communication between the builder and the homeowners has slowed down. He requests the Village not to take action to approve the next addition of Algonquin Lakes Subdivision until the resident's are dealt with fairly.
