#### MINUTES OF THE REGULAR MEETING

# OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON AUGUST 7, 2001

<u>CALL TO ORDER</u>: Village President Ted Spella called the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz Clerk called the roll.

PLEDGE TO FLAG: Clerk Kautz led all present in the Pledge of Allegiance.

**ADOPT AGENDA:** Moved by Schmitt, seconded by Wolski, to adopt tonight's agenda as printed adding 6A, Continue Public Hearing, moving Omnibus Item 8A1 to Discussion, and deleting Item 15, Executive session.

Voice vote; ayes carried.

### **DISCUSS ITEM REMOVED FORM OMNIBUS AGENDA:**

Attorney Rogers, explained that only the wording from "and" to "or" gives the courts room to find a guilty verdict for speeding tickets under 10 miles an hour over the limit. After further discussion, the following motion was offered.
