#### MINUTES OF THE REGULAR MEETING

# OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON OCTOBER 2, 2001

<u>CALL TO ORDER</u>: Village President Ted Spella called the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz Clerk called the roll.

**ROLL CALL:** Present: Trustees Jim Steigert, Barbara Read, Linda Wolski, Bob Smith, Constance Donner, John Schmitt. A quorum was established.

Staff in attendance: Administration – William Ganek, Robert Mitchard, Jeff Mihelich, Russell Laine. Attorney – H. David Rogers, Engineer – Frank Cuda.

PLEDGE TO FLAG: Clerk Kautz led all present in the Pledge of Allegiance.

**ADOPT AGENDA:** Moved by Donner, seconded by Wolski, to adopt tonight's agenda as printed deleting Item 14, Executive Session. Voice vote; ayes carried.

#### **AUDIENCE PARTICIPATION:**

- 1. Kent Miller, President of Founders Days Committee, thanked the Village for its support during this past Founders Festival. He also presented checks in the amount of \$2,500. each to the Police and Public Works Department in appreciation for there help during the festival. They are also going to present a check to the Fire District.
- 2. Vince Lobasco, 570 Tanglewood Ct., Algonquin, requested a stop sign be placed at Tanglewood and Highland. He said vehicles' cutting down Tanglewood is creating a dangerous traffic pattern. He also wants a dead end sign at the entrance to Tanglewood Court to stop traffic. Staff will look into both issues. Mr. Lobasco also complained about the sewer portion of his water bill saying most of the water during the summer goes into the ground from watering. Mr. Ganek informed him that the sewer portion offsets the water portion, which is used at a very high rate at that time of the year. If the sewer service was not billed, the water portion would be very high.
- 3. Myrina Figiel, Algonquin, said she and others are organizing an appreciation festivity for support of local fire, paramedics, and police. It will be held in Towne Park on October 21. Savage Entertainment is offering a climbing wall and Ms. Figiel is requesting permission for this form of entertainment. President Spella asked if there is proof of liability insurance and was told that Savage will provide it. This matter will be handled administratively.
