#### MINUTES OF THE REGULAR MEETING

# OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON APRIL 16, 2002

<u>CALL TO ORDER</u>: In the absence of Village President Ted Spella, Trustee Schmitt called the regular meeting to order at 8:00 PM. He then asked Village Clerk Jerry Kautz to explain the protocol. Kautz stated the Board would be required to appoint a temporary chairperson for tonight's meeting, and he then called the roll.

After a quorum was established, Clerk Kautz requested a motion to appoint a chairperson. Moved by Smith, seconded by Read to appoint Trustee John Schmitt as Temporary Chairman. Roll call vote; voting aye -- Smith, Read, Schmitt, Donner, Wolski, Steigert. Motion carried; 6-ayes, 0-nays.

**PLEDGE TO FLAG:** Clerk Kautz led all present in the Pledge of Allegiance.
