STAFF REPORTS:

<u>VILLAGE MANAGER</u> ~ Mr. Ganek reported the following:

With the finalization of Riverfront Park improvements, the State has mailed the Park Grant check in the amount of \$175,000. to the Village. Kelliher Park improvements are almost complete and another Park Grant of \$400,000. is due the Village. The Algonquin Lakes Park plan is completed and will go out for bids. With these parks the Village will have 24 parks with more on the way.

PUBLIC WORKS DIRECTOR ~ Mr. Mitchard reported the following:

Facility site grading is 98% complete with curbs and gutters being installed. Brick and block will commence next week. The pad for the salt storage dome is being prepared. Cardinal Drive improvements are progressing, and the Wilbrandt/Arrowhead water main project will begin soon. The Lions/Armstrong Municipal Pool repair work will begin late October. Bike paths to the Library have been installed. Wetland mitigation is ready to begin.

The road will be open during the final lift in about four weeks. The Huntington Booster Station and Harrison Streetscape plans are going out for bids.

The D.A.R.E. Program is about to begin with new curriculum. Working with the Police Commission on the promotional exam for a Sergeant position.

VILLAGE ATTORNEY ~ Mr. Rogers reported the following:

Staff has been involved with zoning matters, contract reviews, and property acquisition.
