<u>CALL TO ORDER</u> Village President Ted Spella called the regular meeting to order at 8:12 PM. He then asked Village Clerk Jerry Kautz to call the roll.

**ROLL CALL:** Present: Trustees Jim Steigert, Barbara Read, Bob Smith, Constance Donner, John Schmitt, Linda Wolski. A quorum was established.

**PLEDGE TO FLAG:** Clerk Kautz led all present in the Pledge of Allegiance.

**ADOPT AGENDA:** Moved by Schmitt, seconded by Smith, to adopt tonight's amended agenda as printed, including Item 15, Executive session to discuss property acquisition. Voice vote; ayes carried.

**PRESENTATION:** Representatives from the Algonquin Founders Days Committee thanked the Village for its assistance and efforts during this summer's festival and then presented a donation check in the amount of \$2,500. to both the Police Department and the Public Works Department.

## **AUDIENCE PARTICIPATION:**

1. Pamela Perrotte, 910 Susan Court, Algonquin, asked if a certain floodlight at the Wastewater Treatment Plant behind her home could be changed in some way as it shines into her home during the night. Ms. Zimmerman responded the Department is in the process of changing the light standard so as to correct the problem.

2. Moved by Smith, seconded by Wolski, to approve the lowest <u>responsible</u> bid and award the contract for the Lions-Armstrong Memorial Pool Project to Scheafges Brothers in the amount of \$203,217.

Roll call vote; Voting aye -- Smith, Read, Schmitt, Donner, Wolski, Steigert. Motion carried; 6-ayes, 0-nays.

3. Moved by Smith, seconded by Wolski, to approve parking limitations at Jacobs High School as stated in Chief Laine's memo of October 4, 2002.

Roll call vote; Voting aye -- Smith, Read, Schmitt, Donner, Wolski, Steigert. Motion carried; 6-ayes, 0-nays.
