MINUTES OF THE REGULAR MEETING

OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON APRIL 15, 2003

<u>CALL TO ORDER</u>: Acting Village President John Schmitt called the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz Clerk called the roll.

ROLL CALL: Present: Trustees Jim Steigert, , Bob Smith, Constance Donner. Absent; Barbara Read, Linda Wolski. A quorum was established.

Staff in attendance: Administration – William Ganek, Bob Mitchard, Jeff Mihelich, Russell Laine. Attorney – H. David Rogers, Engineer – Frank Cuda.

PLEDGE TO FLAG: Clerk Kautz led all present in the Pledge of Allegiance.

ADOPT AGENDA: Moved by Schmitt, seconded by Smith, to adopt tonight's agenda as printed, including Item 15, Executive Session to review past executive minutes. Voice vote; ayes carried.

PROCLAMATION: Clerk Kautz read proclamation in honor of Arbor Day, April 25, in Algonquin.

AUDIENCE PARTICIPATION:

- 1. James Ranallo, 635 Clearview Court, Algonquin, congratulated the winners in the recent municipal election and offered his thanks to Linda Wolski for her four years of service to the Village. He raised concerns about some residents living along the public open space, formerly the proposed Northern By-pass Corridor, and having permanent structures such as swing sets, and other personal items built on public land. He requested the Village to enforce the ordinances against such violations.
- 2. Mary Stratejcruk, 326 Jefferson street, Algonquin, voiced strong concern, as a resident and an election judge, regarding candidate election material of Linda Wolski and Barbara Read being placed at the polling place in Historic Village Hall on election day or the days before. She said this is in clear violation of election laws.
