MINUTES OF THE REGULAR MEETING

OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON JULY 6, 2004

<u>CALL TO ORDER</u>: Acting Village President John Schmitt called the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

ROLL CALL: Present: Trustees Robert Smith, John Spella, John Schmitt, Jim Steigert.

Absent: Constance Donner, Barbara Read A quorum was established.

Staff in attendance: Administration – William Ganek, Robert Mitchard, Craig Arps, Russell Laine.

Attorney – Dave Rogers, Engineer – Frank Cuda.

PLEDGE TO FLAG: Clerk Kautz led all present in the Pledge of Allegiance.

ADOPT AGENDA: Moved by Schmitt, seconded by Smith, to adopt tonight's agenda as printed, deleting item 15, Executive Session.

Voice vote; ayes carried.

<u>AWARDS</u>: The following Algonquin residents were the recipients of awards for their participation in the Recycled Art Contest, held June 19th. The theme of this year's contest was "Wild About Conservation". First Place - The Efken Family, Second Place - Steven Holme.

AUDIENCE PARTICIPATION:

- 1. Paul Calysinski, Owner of a local bait shop, proposes a Family Fishing Derby for Cat Fish to be held the Saturday of Founders Days, July 31, from 7:00 AM to 3:00 PM. The event would take place all along the Fox River. They would be using the pavilion at Ericson Marine, and he requests approval to have a Blues Band that would perform at Ericson's Marina until 10:30 PM. He was informed he would need approval from the Village Board and all plans must be submitted as soon as possible so this matter would be discussed at the next Board meeting. On a second issue, he asked if the Village could place portable toilets at various locations in parks along the Fox River since more people are fishing these days. Acting President Schmitt stated that the porta-potties would create more problems than be useful.
- 2. Neil Costello, 111 Hubbard Street, Algonquin, voiced concern regarding a neighbor's garage being built but having no siding installed for over a year. He sited a village code that states the project must be completed in 180 days and an extension of 90 days has to be submitted in writing, Mr. Costello said the building is a "slum" and he believed one of the neighbor's children was occupying the garage. He added, several incidents have occurred involving this family with no resolve. Mr. Arps replied that he recently inspected the garage building and the owner will have the siding installed soon, he also found no evidence of anyone living in the structure.

Mr. Costello said there is another home on the street that has been abandoned for some time and that it is rodent and termite infested. In addition, the cul de sac is cluttered with various debris. Mr. Ganek said Staff will look into the abandon house issue and inspect for clean up of the cul de sac.
