The consensus of the Board was that the plan looked good and to continue on. Mr. Ganek also announced the next Committee of the Whole may be cancelled due to lack of items on the agenda.

South Algonquin Phase 2 improvements are moving along well. His Staff has been preparing for the Founders Days Festival to be held this weekend. He is completing review of all Public Works job descriptions. The Bunker Hill Improvements bid date is set for August 10.
