MINUTES OF THE REGULAR MEETING

OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON OCTOBER 5, 2004

<u>CALL TO ORDER</u>: Acting Village President John Schmitt called the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

ROLL CALL: Present: Trustees Constance Donner, Robert Smith, John Spella, John Schmitt, Barbara Read, Jim Steigert. A quorum was established.

Staff in attendance: Administration – William Ganek, Michele Zimmermann, Jeff Mihelich, Russ Laine, Jenna Kollings. Attorney – Dave Rogers, Engineer – Jim Wallace.

PLEDGE TO FLAG: Village Clerk Kautz led all present in the Pledge of Allegiance.

ADOPT AGENDA: Moved by Smith, seconded by Read, to adopt tonight's agenda as printed, deleing item 16, Executive Session.

Voice vote; ayes carried.

PRESENTATION: Kevin Meyer and Jerry McKevily, representing the Algonquin Founders Days Committee, presented check in the amount of \$1,000. to the Algonquin Police Explorers in appreciation for the Village's assistance during the July festival.

AUDIENCE PARTICIPATION:

- 1. Tom Gerke, 3571 Lakeview Drive, Algonquin, thanked the Village Staff for getting back to them with information, but he voiced complaint regarding traffic being diverted onto his street from Bunker Hill Drive, which is under construction. He requested the Village to better control traffic that is speeding on Lakeview Drive. He wants stop signs installed since there are no sidewalks in his subdivision. In addition, he would like to see the mobile radar-warning unit be placed on Lakeview to warn drivers of their speed. Mr. Gerke recommends that a letter of warning be sent to all residents in a construction area, not just to those on the street most impacted. Ms. Zimmermann, from Public Works, reported on construction schedules for the area. Village Manager, Ganek, said the mobile unit will be installed as soon as possible, and Chief Laine will look into temporary signs for the neighborhood.
- 2. Tony Quagliano, 3671 Lakeview, and Bill Weck, 3640 Lakeview, expounded further to what Mr. Gerke stated. They wanted to know why all road projects near Square Barn Road are all being worked on at the same time, dumping traffic on to their streets? They also are concerned about detour signs being removed causing further traffic problems. In response, Ms. Zimmermann said the Village is working to resolve the detour issues.

Moved by Smith, seconded by Steigert, to recommend approval of the Western By-pass Section 4 (f) Mitigation Plan dated September 2004 with the understanding that the Village of Algonquin shall be consulted during the preparation of final construction plans to ensure the appropriate development of Village park lands; the installation of necessary roadway aesthetics, sound and landscape treatments; and the preservation and/or relocation of existing trees wherever possible. Roll call vote; voting aye -- Steigert, Smith, Spella, Schmitt, Read. Voting nay -- Donner. Motion carried; 5-ayes, 1-nay.
