

# OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON JUNE 21, 2005

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

**ROLL CALL:** Present: Trustees John Spella, Robert Smith, Jerrold Glogowski, Jim Steigert, Brian Dianis, Barbara Read. A quorum was established.

Staff in attendance: Administration – William Ganek, Robert Mitchard, Jeff Mihelich, Russ Laine. Attorney – Kelly Cahill, Engineer – Frank Cuda.

**PLEDGE TO FLAG:** Village Clerk Kautz led all present in the Pledge of Allegiance.

**ADOPT AGENDA:** Moved by Smith, seconded by Spella, to adopt tonight's agenda as printed, including item 15, Executive Session to discuss property acquisition. Voice vote; ayes carried.

### **AUDIENCE PARTICIPATION:**

- 1. Paul Calysinski, 528 Apache Avenue, Carpentersville, Owner of the Bait Shop at Ericson's Marina, complained of closure of N. Harrison Street for construction causing undue harm to his business and asked that the street be open during the day with a flagman instead of detouring traffic away from the Marina. The scheduled four weeks will hurt business greatly. Mr. Mitchard explained the detour patterns and will investigate if some other arrangement can be made.
- 2. Carl Westwick, Steve Andrews, and Diane Zellner, al of Fox River Drive, Algonquin, voiced concern about the street and sidewalk improvements in their area including removal of certain trees specifically Mr. Andrews' cedar tree. They also do not want sidewalks in the neighborhood as it would look like "Chicago", and Mr. Andrews says there is not much traffic. President Schmitt said sidewalks are a safety issue and will be installed. Mr. Mitchard said the Village has given residents time to remove or relocate trees that are in the right-of-way. Staff will inspect the area to see if any trees can be saved. Parkways are need so snow removal of streets will not be pushed onto sidewalks which residents are responsible for cleaning during storms. Trustee Smith requested to have the Village Board review any future changes to this plan so as not leaving the sole discretion to Staff.
- 3. Mrs. Krup of North River Road, Algonquin, voiced concern regarding the "Scenic Road" designation in front of her property. She was assured by Mr. Ganek that it will not affect her in any way.

It was immediately requested by President Schmitt to amend the motion adding the price of \$162,000.

Moved by Smith, seconded by Steigert, to add \$162,000 purchase price to the original motion. Roll call vote on the motion as amended; voting aye -- Smith, Glogowski, Dianis, Steigert, Read, Spella. Motion carried; 6-ayes, 0-nays.

1. Trustee Dianis requested discussion of the "National Night Out" event placed on the next Committee of the Whole agenda.

**ADJOURNMENT:** There being no further business, it was moved by Smith, seconded by Spella, to adjourn.
