

# OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON JULY 19, 2005

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

**ROLL CALL:** Present: Trustees John Spella, Robert Smith, Jerrold Glogowski, Jim Steigert, Brian Dianis, Barbara Read. A quorum was established.

Staff in attendance: Administration – William Ganek, Robert Mitchard, Katie Thornton, Craig Arps, Russ Laine. Attorney – H. David Rogers, Engineer – Frank Cuda.

PLEDGE TO FLAG: Village Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Read, to adopt tonight's agenda as printed, including item 16, Executive Session to discuss property acquisition. Voice vote; ayes carried.

**AWARDS:** Ms. Katie Thornton, Community Development, reported on the Village Staff selection of Water Conservation Awards to children from Kindergarten to 4th Grade who made posters depicting various ways to conserve water. The winners were as follows and received their awards from President Schmitt; Rachelle Jacobs, Rylee Fava, Maysie Richter, Ashley Czerwinski. Not in attendance were Marisa DalCerro, and Jessamine Clavero.

### **AUDIENCE PARTICIPATION:**

1. James Ranallo, 635 Clearview Court, Algonquin, complained about the Village's decision to go to a "Yellow" water status. He prefers to leave it in a "Red" no watering at all position. He is also against the proposed new "Orange" status the Board is considering. As a matter of fact, he requests Red status all year long to preserve water. Mr. Ganek responded by saying the aquifer is responding to the Yellow condition and therefore residents can at least water in restricted times to save shrubs and plants. Car washing is also allowed during the restricted time. on another issue, Mr. Ranallo is concerned about excessive dog waste in parks and on village streets and lawns. He said the ordinance reads dog owners must have pets on an eight foot leash while the park signs say 10 feet, but also that he notices dogs run loose and the Village does not enforce this ordinance. Thirdly, he wants to know, by the next Board meeting, how many village employees have company vehicles supplied to them and where do they live.

The Thursday night summer concerts in Riverfront Park are going well. Staff is making progress on the updated website. The new recycling carts will be available August 8th and will take about a week to distribute throughout the village.

#### **PUBLIC WORKS DIRECTOR** Mr. Mitchard reported the following:

South Algonquin Phase 3 is going well. The new water tower is now filled and the yellow status is in place. The residents are using about 4 1/2 million gallons a day which is acceptable for this time of year. The Alta Vista road work is progressing with the binder being laid. Water Treatment Plant 3 plumbing is being installed along with filtration.
