

# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, ILLINOIS HELD IN VILLAGE HALL ON JUNE 19, 2012

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll.

<u>ROLL CALL</u>: Present: Trustees Debby Sosine, Robert Smith, Jerry Glogowski, Jim Steigert, John Spella, Brian Dianis. A quorum was established. Staff in attendance: Bill Ganek, Village Manager; Russ Farnum, Director of Community Development; Bob Mitchard, Director of Public Works; Russ Laine; Chief of Police; Kelly Cahill; Attorney.

PLEDGE TO FLAG: Village Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Dianis, to adopt tonight's agenda, including Item 16, Executive Session, for litigation, personnel, review past executive minutes, and consider release. Voice vote: ayes carried.

<u>PRESENTATION</u>: The president of the McHenry County Conservation District, Kevin Ivers, gave an overview presentation on the responsibilities of the District. They control bike paths, programs for residents, and have volunteers providing 14,000 hours of service annually. Open land has been acquired throughout the county.

#### STAFF REPORTS:

ADMINISTRATION ~ Mr. Ganek reported the following:

1- The May 5 E-cycling program collected 67,155 lbs. of electronics; it was very successful. 2- Water conservation has gone from green to yellow status. Mr. Mitchard said the village is holding its own. 3- The lunch hour entertainment series begins this week. 4- The State of Illinois is now three months behind in issuing sales tax revenue to the village.

## COMMUNITY DEVELOPMENT ~ Mr. Farnum reported the following:

1- Conservation Day was last Friday and fairly successful. He thanked staff who worked the event, especially Public Works for their setup and teardown efforts. 2-The Downtown Steering Committee will meet on June 28. 3- The Ford school moving project went off without any problems except some traffic delays.

<u>PUBLIC WORKS</u> ~ Mr. Mitchard reported the following construction updates:

1- The Edgewood Drive storm sewer construction will move from east to west, but AT&T is still delaying the project. The project is 10 days behind schedule. 2- Spring Creek Road repairs are being slowed by the lack of grinding of the old surface. 3- Sidewalk work continues at Riverside Plaza. There are grade issues that have to be resolved. 4- Bypass bids have been opened with the low bidder at around \$30 million. 5- Water conservation education and enforcement will help in the effort to keep aquifers stable.

# <u>POLICE DEPARTMENT</u> ~ Chief Laine reported the following:

1- Three violations will be before the Liquor Commission next Tuesday. 2- DARE Officers Bucci and Miller have completed the new DARE training program. 3- Staff is still working on plans for Founders' Days. 4- Chief attended a Special Olympics Medal Presentation and met several folks from the Algonquin area.

## VILLAGE ATTORNEY ~ Ms. Cahill reported the following:

1- Her office has been involved with ongoing litigation, community development issues, and review of agreements.
