

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON NOVEMBER 6, 2007

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

ROLL CALL: Present: Trustees Robert Smith, Jerry Glogowski, Deborah Sosine, Brian Dianis, John Spella, Jim Steigert. A quorum was established. Staff in attendance: Administration – William Ganek, Michele Zimmerman, Jeffrey Mihelich, Russ Laine. Attorney – Ryan Farrell.

PLEDGE TO FLAG: Village Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Glogowski, to adopt tonight's agenda as printed deleting item 16, Executive Session, and, at the request of Trustee Spella, moving item 8-A2, an ordinance that would provide a Class 4 Liquor License, to item 9, for discussion.

Voice vote; ayes carried.

PRESENTATION: Chief Russ Laine and President Schmitt presented a "Saved by the Belt" award to Police Officer Dykstra who was involved in a recent severe car accident involving a drunk driver, and was saved from critical injuries by wearing his seat belt during his patrols.

AUDIENCE PARTICIPATION:

1. Barbara Read, 1200 windy Knoll Drive, Algonquin, voiced concern regarding the proposed change to the liquor license ordinance that would allow certain service businesses to serve alcohol to customers. She asked the Board to not pass the ordinance.

Moved by Spella, seconded by Glogowski, to approve the Consent Agenda of November 6, 2007 as listed. Voice vote; ayes carried.

Moved by Steigert, seconded by Dianis, to approve the Omnibus Agenda of November 6, 2007

Roll call vote; voting aye -- Steigert, Smith, Glogowski, Sosine, Spella, Dianis. Motion carried; 6-ayes, 0-nays.

DISCUSSION OF ITEM REMOVED FROM OMNIBUS:

In regard to the proposed change to the Liquor Ordinance, Chapter 33, Class A-4, the following comments were offered by the Board:

Trustees Steigert, Dianis, and Glogowski request the matter be further discussed at the next Committee of the Whole meeting. Trustee Spella voiced his opposition to allowing a beauty shop or manicure salon from serving alcoholic drinks to patrons. Trustee Sosine stated this matter should be voted upon tonight. Trustee Smith and President Schmitt both said this has been discussed at the Committee of the Whole and that since the Liquor Ordinance was tighten up last year this change would give the Village the venue to allow certain businesses an enhancement to

that business. President Schmitt gave an example such as a cigar shop owner being able to offer a glass of brandy to someone sampling a fine cigar. He then said he would place this matter up for further discussion at the next Committee of the Whole meeting.

Roll call vote; voting aye -- Dianis, Spella, Steigert, Smith, Glogowski, Sosine. Motion carried; 6-ayes, 0-nays.
