

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, ILLINOIS HELD IN VILLAGE HALL ON JULY 3, 2012

CALL TO ORDER: Village President John Schmitt brought the regular meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll.

<u>COMMITTEE OF THE WHOLE</u> ~ The Committee met on June 12 with items being on tonight's Omnibus Agenda. No board action is required at this time:

<u>VILLAGE CLERK</u> ~ Clerk Kautz reported future meetings of Boards and Commissions.

STAFF REPORTS:

ADMINISTRATION ~ Mr. Ganek reported the following:

1- The Village received an Award of Distinction from the Government Finance Officers Association (GFOA) for financial reporting and audit preparation. 2- The Village also received a Green Award from the McHenry County Health Department for its recycling program to keep from filling landfills needlessly.

<u>COMMUNITY DEVELOPMENT</u> ~ Mr. Arps reported the following:

1- Hobby Lobby will get its occupancy permit soon. 2- Radio Shack plan review is in process. 3- The department is doing work for Carpentersville under the intergovernmental agreement.

<u>PUBLIC WORKS</u> ~ Mr. Mitchard reported the following construction updates:

1- Edgewood Drive work moves forward now that AT&T is co-operating in handling the utilities. The Ratt Creek Bridge reinforcements are being poured and retaining walls are in place. 2- Spring Creek Road #2 road work continues with #3 to start soon. 3- Riverside Plaza sidewalk work is being completed and should be ready for Founders' Days weekend. 4- The Village water status is still yellow, and the recovery systems are holding their own, even with this hot weather. 5- The water emergency connection design and agreement with Carpentersville are being prepared and should be ready soon. 6- The department is assisting Villa Park with repairs due to the recent severe storms that hit that area this week.

<u>POLICE DEPARTMENT</u> ~ Deputy Chief Urban reported the following:

1- The department is finalizing plans with the Founders' Committee.

VILLAGE ATTORNEY ~ Ms. Cahill reported the following:

1- Her staff has been involved with community development issues, public works matters, and ordinance and agreement drafting and reviews.

CORRESPONDENCE & MISCELLANEOUS:

1. Trustee Smith asked that there be better communication between the village water billing department and landlords who have renters leaving and owing money for water bills. Mr. Ganek asked if this should apply to all rental properties in the village, both residential and business, with Mr. Smith replying in the affirmative. Mr. Ganek said it would be difficult for village staff to bill renters at present and also let landlords know who is in arrears. Trustee Sosine agreed with the village stance and said that landlords should be held responsible for the water bills when renters do not pay. President Schmitt asked staff to

look into ways the village could notify the property owners who request when renters fall in arrears.

2. Trustee Glogowski asked the police to strongly enforce firework violations, especially in light of the extremely hot and dry weather conditions. Deputy Chief Urban replied that the officers will be very vigilant this year. Mr. Glogowski also said the work crews on Edgewood Drive are not properly replacing the "road closed" signs at night. 3. Trustee Smith asked about the status of permanent signals at Lake Cook and Algonquin Roads. The response was that the signal arms are on order with a 14-week lead time.
