

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, ILLINOIS HELD IN VILLAGE HALL ON AUGUST 7, 2012

CALL TO ORDER: Village President John Schmitt brought the regular meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll.

ROLL CALL: Present: Trustees Debby Sosine, Robert Smith, Jerry Glogowski, Jim Steigert, Brian Dianis, John Spella. A quorum was established. Staff in attendance: Bill Ganek, Village Manager; Russ Farnum, Community Development Director; Bob Mitchard, Public Works Director; Steve Kuzynowski, Deputy Police Chief. Attorney: Kelly Cahill

PLEDGE TO FLAG: Village Clerk Kautz led all present in the Pledge of Allegiance.

ADOPT AGENDA: Moved by Spella, seconded by Dianis, to adopt tonight's agenda, including Item 15, Executive Session, for Collective Bargaining, Acquisition of Property, and Personnel. Voice vote: ayes carried.

AUDIENCE PARTICIPATION:

1. Tom Gummow, 920 Harper Drive, Algonquin, voiced complaint regarding a portion of Edgewood Drive from Cardinal to Harper that is closed due to construction. He said his fellow homeowners have to drive a 9-mile stint just to get to Route 31. He wanted to know why the village will not open the temporary barricades to allow locals to use that small length of road. He was told that, with construction trucks and equipment in use in that area, the liability would be too great for the village.

1- Hobby Lobby is now stocked; the grand opening will be August 13. The actual open date for business is this Friday. 2- The Downtown Planning Steering Committee will review all recent public comments and will meet in mid-September.

PUBLIC WORKS ~ Mr. Mitchard reported the following:

1- Edgewood Drive is 48 percent complete and six days ahead of schedule. Further utilities relocations are needed by Comcast, Com Ed, and AT&T. Culvert bridges are being constructed and should be complete within weeks. Overall completion should be by this coming winter. 2- Spring Creek Projects 2 and 3 are continuing. 3- Western bypass construction also continues with bridge work and bike path pre-construction meetings to be held soon.
