

# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, ILLINOIS HELD IN VILLAGE HALL ON NOVEMBER 20, 2012

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll.

<u>ROLL CALL</u>: Present: Trustees Debby Sosine, Jerry Glogowski, Jim Steigert, Brian Dianis, John Spella, Robert Smith. A quorum was established. Staff in attendance: Bill Ganek, Village Manager; Robert Mitchard, Public Works Director; Russell Laine, Chief of Police; and Attorney Kelly Cahill.

PLEDGE TO FLAG: Scout Jack Schmitt-Vallejo led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Glogowski, to adopt tonight's agenda, including 15, Executive Session, to discuss property acquisition and personnel. Voice vote: ayes carried.

<u>ADMINISTRATION</u> ~ Mr. Ganek reported the following:

1- The Downtown Planning Meeting will be held November 28 at 7 p.m. at St. John's School. 2- The Tree of Honor has been installed in the lobby of Village Hall. The leaf purchase cost goes to the village tree replacement program. 3- Due to the holiday this week, Waste Management pickup will be delayed by one day. 4- Holiday light recycling will take place from November 15 through January 16. 5- "Rock on the Fox" will be held on December 1. 6- The state reports that the western bypass is ten percent complete.

# PUBLIC WORKS ~ Mr. Mitchard reported the following:

1- The wastewater treatment plant flood had staff responding quickly and returned to full service in two days. The insurance company has been notified. Costs were approximately \$22,000. A SCADA system check is now taking place. 2- Edgewood Drive is now scheduled to open tomorrow at 3 p.m. Barricades will be removed although some temporary closures might take place as finishing touches are completed. Temporary striping of the road is finished with permanent strips being done after winter. 3- Spring Creek #3 is close to completion. 4- The road salt brine system has been installed by inhouse staff. 5- Staff is working on preliminary budget numbers for next year.

## <u>POLICE DEPARTMENT</u> ~ Chief Laine reported the following:

- 1- The department's on-site accreditation process is scheduled for November 28 and 29.
- 2- The department received a grant for two automatic defibulators. 3- A recent tobacco compliance check was done by the department with 20 retailers complying and four that sold to minors. Those four are scheduled appear in our Municipal Court.

# VILLAGE ATTORNEY ~ Ms. Cahill reported the following:

1- Her office has dealt with village administration and drafting ordinances. Other matters will be discussed in executive session.

<u>RECESS INTO EXECUTIVE SESSION</u>: Moved by Smith, seconded by Sosine, to recess into Executive Session to discuss acquisition of property and personnel. Roll call vote: voting aye –Glogowski, Steigert, Smith, Sosine, Dianis, Spella. Motion carried: 6-ayes, 0-nays. Recessed at 7:51 p.m.

<u>RECONVENE</u>: President Schmitt requested a roll call. Present: Trustees Debby Sosine, Jerry Glogowski, Jim Steigert, Brian Dianis, John Spella, Robert Smith. A quorum was established. Reconvened at 8:42 p.m.

<u>REPORT</u>: Attorney Cahill reported acquisition of property and personnel were discussed. The following action is required for one item.

1. Moved by Sosine, seconded by Dianis, to authorize the village to purchase the Griesman property located on South River Road, PIN# 19-34-176-003, in the amount of \$32,000 pursuant to the terms in our Letter of Intent between the village and property owners, and authorize staff to execute all documents necessary to effectuate the closing. Roll call vote: voting aye – Steigert, Glogowski, Smith, Sosine, Dianis, Spella. Motion carried: 6-ayes, 0-nays.

## **NEW BUSINESS:**

1. Trustee Sosine requested the village to ask IDOT to once again allow right turn on red on Eastgate at Route 62 heading eastbound.

<u>ADJOURNMENT</u>: There being no further business, it was moved by Glogowski, seconded by Sosine, to adjourn. Voice vote: ayes carried.
