

# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, ILLINOIS HELD IN VILLAGE HALL ON DECEMBER 4, 2012

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll.

<u>ROLL CALL</u>: Present: Trustees Debby Sosine, Jerry Glogowski, Jim Steigert, Brian Dianis, John Spella, Robert Smith. A quorum was established. Staff in attendance: Bill Ganek, Village Manager; Russ Farnum, Community Development Director; Bob Mitchard, Public Works Director; Russell Laine, Chief of Police; and Attorney Kelly Cahill.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Dianis, to adopt tonight's agenda, including Item 16, Executive Session, to discuss personnel. Voice vote: ayes carried.

#### ADMINISTRATION ~ Mr. Ganek reported the following:

1- Illinois' governor signed a bill extending the final day of petition filing to December 26. 2- The last Committee of the Whole for the month will be canceled. 3- The January 1 board meeting will either be cancelled or moved to January 2, 2013.

## <u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported the following:

1- Downtown planning is proceeding with the next steering committee to be held on December 13 at Historic Village Hall. 2- A Downtown Partnership mixer will be held at Martini's on Main next Monday. 3- Mr. Farnum thanked Landvision, our village attorney's office, and Burke Engineering for their input for a McHenry County planning session sponsored by Algonquin. Several real estate development talks are taking place.

#### <u>PUBLIC WORKS</u> ~ Mr. Mitchard reported the following:

1- Edgewood Drive is now open and good shape. 2- A punch list is in place for the 911 memorial site. 3- Streets Division has the salt brine system in operation. 4- Plow operator training is in progress. 5- The snow fences have been installed throughout the village. 6- Staff is working on the capital plan budget for next fiscal year.

## POLICE DEPARTMENT ~ Chief Laine reported the following:

1- The department has participated in the Onsite Illinois Accreditation Evaluation Project. The report is forthcoming from experts in several different categories. 2- Last Sunday, eight members of the department participated in the Shop with a Cop Program for underprivileged children. 3- Early this morning, officers spotted a suspicious vehicle parked near Square Barn Road, investigated and eventually arrested two burglars on various charges. They were stealing items from unlocked cars in the neighborhood.
