DISCUSSION OF OMNIBUS ITEM:

1. Mr. Ganek stated the Committee of the Whole directed staff to draft an ordinance that would increase the State mandated fine of \$250 for violators of the Handicapped Parking ordinance to \$500 in Algonquin as a home rule community. Since most businesses in town have converted to the signs stating a \$250 fine, it was suggested to wait at least six months before approving the new ordinance as the new signs were just installed. Trustee. Smith insisted on doing the change immediately but consensus of most of the Board members were in favor of holding off for a six month period before forcing local businesses to change the signs one more time. President Schmitt said the Village, who produced the signs at Public works could lose thousands of dollars in cost and labor. Attorney Cahill said the Village can not selectively place signs of differing fines, it must be uniform throughout the Village. The Village President said six months wait is not out of line and forcing the business owners to change immediately is just not "business friendly". It was suggested that the Board could pass the ordinance tonight but place an effective date six months hence.

Moved by Steigert, seconded by Smith, to pass <u>ORDINANCE 2007-O-19</u>, <u>AMENDING EXHIBIT B OF SECTION 1.13-A. PAYMENTS, OF THE ALGONQUIN MUNICIPAL CODE</u> TO BE EFFECTIVE THE DATE OF NOVEMBER 15, 2007

Roll call vote; voting aye -- Steigert, Smith, Glogowski, Sosine, Dianis, Spella. Motion carried; 6-ayes, 0-nays.

COMMITTEE & CLERK'S REPORTS:

<u>COMMITTEE OF THE WHOLE</u> ~ Trustee Glogowski reported on minutes from the May 8 Committee meeting. The minutes are available for review at Village Hall. Items on tonight's Omnibus Agenda were among those discussed at the Committee. The Committee also met tonight in Executive session to discuss appointments to the Economic Development Commission that took place earlier in this meeting. No further action is required at this time.

VILLAGE CLERK ~ Mr. Kautz announced upcoming scheduled Village meetings.

STAFF REPORTS:

VILLAGE MANAGER ~ Mr. Ganek reported the following:

1 - An informational meeting regarding the possible toll bridge in Kane County will take place at Randall Oaks Country Club on May 24. This is to get public input about the project.
2 - The Village received the Cornish Park grant of \$239K to pay off the expenses at the park.
3 - A grant application is being prepared for Ted Spella park improvements.

PUBLIC WORKS DIRECTOR ~ Mr. Mitchard reported the following:

1 - The Wastewater Treatment Plant work is moving along and very busy at the site. 2 - The Village has received many complaints about the odor at the Treatment Plant with Public works staff responding to those calls. Many different remedies are being tried to reduce the odor. The cover for Digester 2 should be in place within a couple of weeks. Staff is moving sludge more quickly to areas outside the village. 3 - Road patch work continues, mowing and sign clean up also is under way. 4 - Hiring interviews are in progress.

COMMUNITY PLANNING DIRECTOR ~ Mr. Mihelich reported the following:

1 - The Committee of the Whole will be discussing the woods Creek Shopping Center, and a medical mart near the Meijer store. 2 - Randall Crossing project is moving along. 3 - Brunswick Zone construction has started. 4 - Main Street Commons is progressing, and the Farmers Market will begin soon. 5 - Members of Staff are visiting fourth grades to talk about water conservation.

VILLAGE ENGINEER ~ Mr. Kerr reported the following:

1 - He thanked the Board for the appointment as Village Engineer. He then gave a short overview of his company that serves twenty communities. 2 - He has been doing reviews for the Community Development Department.

<u>ASSISTANT VILLAGE MANAGER</u> ~ Ms. Kollings announced staff is preparing the Municipal Pool for opening. The water is being tested. 2 - She is waiting for the Census Bureau to respond to the start of the special census in the village.

POLICE DEPARTMENT ~ Chief Laine reported the following:

1 - He was pleased to have the new Deputy Chief and new Sergeant in place as there are new responsibilities for new personnel. 2 - The will be a "Relay for Life" cancer benefit this Friday and Saturday at Jacobs High School. 3 - Many restaurants in the village have participated in person for Bassett Training instead of online. This is a good sign of cooperation. 4 - His staff is preparing for the Memorial Day Parade.

VILLAGE ATTORNEY ~ Ms. Cahill reported the following:

1 - Her office has been working on several issues with Public works, Community Development, and Finance Department.. 2 - Also working on various contracts.

NEW BUSINESS:

1. Trustee Glogowski asked why the east side Jewel does not sell flowers outside like the west side. He was informed that recent village code states it must be an enclosed area and not out in the open. The west side Jewel was grandfathered in.
