

**MINUTES OF  
VILLAGE OF ALGONQUIN  
LOCAL LIQUOR COMMISSION  
Tuesday, February 26, 2013**

CALL TO ORDER: With the Village Board seated as the Liquor Commission, Liquor Commissioner John Schmitt opened the meeting at 7:00 p.m. A roll call showed the following commissioners were present: Debby Sosine, Jim Steigert, Jerrold Glogowski, Brian Dianis, Robert Smith. Absent: John Spella. Staff in attendance: Tim Schloneger, Village Manager; Ed Urban, Deputy Police Chief. Also in attendance were Kelly Cahill, Village Attorney, and Jerry Kautz, Village Clerk.

1. Consider Class E Liquor License for Saheli 609 Corporation, 609 South Main, Algonquin, Illinois 60102 (Huntington and Main), for a Class E liquor license (beer and wine—consumption off premises).

Saheli 609 Corporation, d/b/a Algonquin Citgo, has complied with the Village's requirements by completing the submittal of all documents and fees as required by the Village of Algonquin for obtaining the license pertinent to their establishment. The background processing check has cleared, all fees have been paid, and all documents are in order. Mr. Dianis asked what measures have been taken to ensure selling to minors will not occur. Manager Ron Mudrick said that, in addition to BASSET Training, the corporation provides internal training plus quarterly refresher classes. The cash register also triggers underage IDs. The Commission approved the license.

THE COMMISSION NOW HEARD ALLEGED VIOLATIONS OF CHAPTER 33,  
LIQUOR CONTROL AND LIQUOR LICENSING, OF THE ALGONQUIN MUNICIPAL  
CODE AND APPLICABLE SECTIONS OF THE ILLINOIS COMPILED STATUTES:  
SELLING/SERVING ALCOHOL TO MINORS

1. Chipotle Mexican Grill, Inc. d/b/a Chipotle Mexican Grill, located at 412 South Randall Road

First offense. Pleaded guilty to two liquor violations and a BASSET violation. Commissioner Schmitt levied a \$2,000 fine, a \$500 BASSET violation fine, costs, and BASSET Alcohol Training for all new employees.

2. ITSA-Good Enterprises, Inc., d/b/a BuddyZ A Chicago Pizzeria, located at 2749 West Algonquin Road

First offense. Pleaded guilty to two liquor violations and a BASSET violation. Commissioner Schmitt levied a \$2,000 fine, a \$500 BASSET violation fine, costs, and BASSET Alcohol Training for all new employees.

3. Thai Chilli & Sushi, Inc., d/b/a Bangkok, located at 4077 West Algonquin Road

First offense. Pleaded guilty to two liquor violations. Commissioner Schmitt levied a \$2,000 fine, court costs and BASSET Alcohol Training for all employees. There was no BASSET violation

4. Kaylarose Enterprises, Inc., d/b/a/ Foley's Pub, located at 3965-67 West Algonquin Road

First offense. Pleaded guilty to two liquor violations and a BASSET violation. Commissioner Schmitt levied a \$2,000 fine, a \$500 BASSET violation fine, costs, and BASSET Alcohol Training for all employees.

5. H.B.J. Corporation, d/b/a Wine & Roses, located at 1130 South Main Street

Owner/President John Wesolowski asked for a continuance so that he may obtain an attorney. He was granted time by Commissioner Schmitt to consult with his attorney.

ADJOURNMENT: With no further items on the agenda, Commissioner Schmitt adjourned the meeting at 7:55 p.m.
