

**MINUTES OF  
ALGONQUIN VILLAGE SPECIAL LIQUOR COMMISSION  
HELD IN VILLAGE BOARD ROOM ON APRIL 16, 2013**

**CALL TO ORDER:** With the Village Board seated as the Liquor Commission, in the absence of Liquor Commissioner John Schmitt, Village Clerk Jerry Kautz called the meeting to order at 7:20 p.m.. A roll call showed the following commissioners were present: Robert Smith, Jerrold Glogowski, Debby Sosine, Brian Dianis, Jim Steigert, John Spella. Staff in attendance; Tim Schloneger, Village Manager; Russ Laine, Chief of Police; and Bob Mitchard, Public Works Director. Also present was Attorney Kelly Cahill.

Clerk Kautz then asked for the following motion: Moved by Sosine, seconded by Spella, to appoint Robert Smith as Temporary Chair for this meeting. Roll call vote: voting aye - Sosine, Dianis, Glogowski, Steigert, Smith, Spella. Motion carried: 6-ayes, 0-nays.

**CONSIDER LIQUOR LICENSE APPLICATIONS:** Mr. Smith reported all documents were in order. There were no questions or comments

Temporary Chairman Smith requested the Liquor Commission to Advice and Consent to approve the Algonquin Liquor License Applications for the period beginning May 1, 2013 and ending April 30, 2014. Advice and Consent carried with unanimous ayes.

April 2 - Sent email to corporate office that we had still not received renewal application. Received email back asking what they needed to do to renew liquor license. Advised them we needed application, appropriate documentation, license fee and late fee by April 5 in order to renew.

April 12 – Advised corporate office that the renewal application has not been received and that the next opportunity to have their renewal application approved by the Liquor Commission will be May 7, which means they will be unable to serve alcohol for seven days at a minimum.
