

MINUTES OF THE REGULAR MEETING

OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, ILLINOIS HELD IN THE VILLAGE BOARD ROOM ON OCTOBER 1, 2013

<u>CALL TO ORDER</u>: President John Schmitt brought the regular meeting to order at 7:30 p.m. and requested a roll call by Village Clerk Jerry Kautz.

<u>ROLL CALL</u>: Present: Trustees Debby Sosine, Jerry Glogowski, Jim Steigert, Brian Dianis, Robert Smith. John Spella. A quorum was established. Staff in attendance: Tim Schloneger, Village Manager; Russ Farnum, Community Development Director; Bob Mitchard, Public Works Director; Russ Laine, Police Chief; and Andrez Beltran, Intern. Attorney Kelly Cahill was also present.

PLEDGE TO FLAG: Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Sosine, to adopt tonight's agenda, deleting Item 16, Executive Session, and moving Omnibus items 8.A.(3) (a), (b), and (c) to under Committee of the Whole for individual motions and roll call vote. Voice vote: ayes carried.

<u>RECOGNITION</u>: Gary Hallaert, Utilities Supervisor, was recognized and congratulated as the 2013 Water Distribution Operator of the Year. President Schmitt presented him with the award.

Ordinances Annexing and Zoning River Ridge Estates, North River Road

- (b) Moved by Sosine, seconded by Smith, to pass Ordinance 2013-O-47, Annexing Property to the Village of Algonquin (River Ridge Estates). Roll call vote: voting aye Sosine, Dianis, Glogowski, Steigert, Smith, Spella, Schmitt. Motion carried: 7-ayes, 0-nays.
- (c) Moved by Sosine, seconded by Smith, to pass Ordinance 2013-O-48, Granting Zoning upon Annexation, Rezoning Property to R-1 PUD, and Approving a Preliminary PUD and Plat for Certain Property Known as (River Ridge Estates). Roll call vote: voting aye Sosine, Dianis, Glogowski, Steigert, Smith, Spella. Motion carried: 6-ayes, 0-nays.

Under Public Works & Safety

(1) Moved by Sosine, seconded by Glogowski, to reject the Bids and Waive the Bidding Process to Allow Ruffolo, Inc. of Indian Creek, Illinois, to Enter into an Agreement with the Village for the Riverfront Park Arbor Project in amount of \$38,800. Roll call vote: voting aye – Sosine, Dianis, Glogowski, Steigert, Smith, Spella. Motion carried: 6-ayes, 0-nays.

VILLAGE CLERK ~ Clerk Kautz announced future meetings.

STAFF REPORTS:

<u>ADMINISTRATION</u> ~ Mr. Schloneger reported the following:

1- The Western Bypass is now 39 percent complete with an end date expected to be August 30, 2014. Also, Algonquin Road is expected to be closed at 20-minute intervals as the bridge span beams will be put in place.

<u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported the following:

1. The Chamber of Commerce Business Expo will be October 5 at Jacobs High School. 2- The Public Art Open House is scheduled for October 17 in the Ganek Municipal Center. 3- "It's Our River Day" was held last Saturday with over 1,300 pounds of trash being removed from the river banks.

<u>PUBLIC WORKS</u> ~ Mr. Mitchard reported the following:

1- The Edgewood Drive project continues with the road surface being removed; the road is temporarily one way going southwest toward County Line Road. Storm sewer work is scheduled to take place next spring. 2- Fieldcrest Farms pavement is now complete. 3- There is a delay in the project near Treatment Plant 1 on Souwanas. 4- Fall tree planting will begin soon. 5- Hydrant flushing continues.

POLICE DEPARTMENT ~ Chief Laine reported the following:

1- The DEA prescription drug take-back program will be held October 20, 10 a.m. to 2 p.m. 2- A grant from IDOT for \$33,000 will pay for DUI enforcement during the holidays. 3- Training for video gaming compliance will be conducted by former Deputy Chief Ed Urban in the near future. 4- Staff is studying the new Conceal Carry Law and how it affects the village.

VILLAGE ATTORNEY ~ Ms. Cahill reported the following:

1. Her staff was working on village property, liquor matters, and community development issues.
