Mr. Mason reported that the Petitioner is seeking a Certificate Of Appropriateness to repair and rebuild the existing front porch on a home located at 3 Madison St that faces both Madison and LaFox River Drive. The Petitioner proposes to restore the porch to its original appearance by replacing the existing wrought iron railing with a wood railing and wooden spindles. The deteriorated post on the northeast corner of the porch will be replaced with a new wood post that will match the existing support. The post embedded into the framework on the north end of the porch will also be repaired. All rotting and missing molding will be replaced and a new wood floor will be installed.

Staff feels the proposed request is in keeping with the structure's current appearance And consistent with the Preservation Code. Staff recommends approval of a Certificate of Appropriateness.

After questioning the Petitioner it was recommended that he add decorative cutouts to the skirting dropping from the floor of the porch to the ground on the East side. This will add air passage for under the porch and a decorative element that will be more pleasing.

After further discussion Member Zange moved to recommend approval of the request for a Certificate of Appropriateness to repair and rebuild the front porch on property located at 3 Madison Street Case No. PC07-06 with the understanding that Petitioner will add Decorative cutouts to the skirting dropping from the porch floor to the ground to act as air passage and a more decorative effect.
