<u>ADMINISTRATION</u> ~ Mr. Schloneger reported the following:

1- Staff has been attempting to negotiate a new contract with Waste Management but will prepare a Request for Proposal to see what other options the village may have. 2- He thanked the Boy Scouts for attending our Board meetings and said that if anyone was looking for work with the village in the future, those who are either an Eagle Scout or working toward that end would be placed high on the list for consideration.

### <u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported the following:

1- The Downtown Partnership meeting that was recently held was attended by a few trustees and President Schmitt and was very beneficial. 2- Staff is working on the Complete Streets Project policy. 3- Riverside Plaza work is now in progress with three new projects to be discussed soon. 4-We will be meeting with IDOT regarding implementation details for the bypass.

# PUBLIC WORKS ~ Mr. Mitchard reported the following:

1- Snowstorms have kept his staff very busy; they will now have to watch for flooding as temperatures rise. Potholes will be a major issue once the melting stops. 2- The roof on the Ganek Municipal Center is leaking in areas due to ice dams that form and back up under the shingles in heavy snow. 3- There have been two bid openings--the Souwanas Creek restoration project that came in at \$320,000 and the Copper Oaks Phase One project that came in under estimates by \$200,000. 4- Department staff has been discussing the creation of a Code of Conduct for Public Works.

# POLICE DEPARTMENT ~ Chief Laine reported the following:

1- With a grant from the Illinois State Liquor Control Commission, the department did a tobacco compliance check for selling to minors. There was only one violation that will be handled in Municipal Court. 2- An officer will be participating in the "Polar Plunge" where various officers and personnel from all over will plunge into Lake Michigan once every hour for 24 hours to solicit funds for the upcoming Special Olympics.

## VILLAGE ATTORNEY ~ Ms. Cahill reported the following

1. Her staff has been working on litigation, administration matters, and community development issues.
