# **Construction Update 2014**

Warmer weather means the start of construction season. Stay up to date with projects, schedules, and detours online at www.algonquin.org. The following are some highlights for the upcoming construction season:

**IL-31 Western Bypass:** The Illinois Department of Transportation project remains on schedule for completion in the fall. Detours and lane closures will remain posted for the duration of the project.

**Indian Grove Subdivision:** The Village will perform reconstruction of roadways in this subdivision, including replacement of storm/sanitary sewer and watermain. This project is scheduled to be completed in December.

**Copper Oaks Subdivision:** Rehabilitation work is scheduled on roadways in this subdivision, including Cumberland Parkway and Glacier Parkway, with work scheduled in two phases: Phase 1 is starting in May, Phase 2 in fall.

**Bunker Hill Drive:** Resurfacing work between Square Barn Road and Saratoga Circle will begin in May. More information on these and other construction projects is available at www.algonquin.org.

# e-Waste Recycling Event

The Village of Algonquin will hold an **e-Waste Recycling Event on May 17 between the hours of 9:00 a.m. and 1:00 p.m.** Bring your unwanted qualifying electronics to the Algonquin Public Works Facility, 110 Meyer Drive. This event will be open to all Village of Algonquin residents.

Electronics that qualify for this event and will be taken at no charge include desktop computers, laptop computers, monitors (CRT & LCD), keyboards, mice, cords, cables (power, USB, etc.), hard drives, cameras (film & digital), miscellaneous computer components, CD-ROM drives, zip drives, tape drives, printers, printer/toner cartridges, televisions, console televisions, cable boxes, satellite dishes, VCRs, DVD players, handheld electronic organizers, handheld games, video game players, joy sticks/game controls, camcorders, radios, stereos, portable CD players, typewriters, word processors, fax machines, scanners, telephones, cellular phones, microwaves, toasters, curling irons, holiday lights, heaters, remotes, vacuum cleaners, and pagers.

Items that are NOT included in this recycling effort include, but are not limited to, white goods (refrigerators, stoves, freezers, dishwashers, dryers, and other appliances labeled as such), air conditioners, humidifiers, VHS tapes, medical waste products, household batteries, and rubber-based items. # **Spring Hydrant Flushing**

As a regular maintenance practice, the Village of Algonquin flushes all fire hydrants throughout the Village twice a year. Spring hydrant flushing is performed in six different zones and will begin on April 14, concluding May 30. Residents are encouraged to avoid using water while hydrant flushing is taking place as temporary losses of water pressure and water discoloration may be possible. # **Spring Cleanup**

In April, the Village, along with Waste Management, will sponsor a Village-wide cleanup program for single-family residences and townhomes that currently receive residential refuse and recycling services. This program is to encourage residents to reduce fire hazards in their homes and to "spruce up" their neighborhoods. STICKERS ARE NOT REQUIRED FOR THIS SPE-**CIAL PICKUP.** Typical items to be discarded include toys. clothes, couches, beds, dressers, and patio furniture.

## Free Leaf & Brush Collection

Waste Management will provide free collection of leaves and branches (tied in bundles which are not more than 4 feet in length and 2 feet in diameter) April 14 - May 9. Leaves must be placed in standard paper yardwaste bags or reusable containers that are clearly marked with a red "X." Place the bags or cans at the curb on your regular collection day. Leaves placed in loose piles will NOT be collected.

Grass clippings and other yardwaste will still require a collection sticker. Any bags or cans that contain leaves mixed with other yardwaste will also require a collection sticker. The stickers for garbage and yardwaste are interchangeable. Please contact Waste Management at 800-796-9696 with questions regarding leaf and brush collection.

## Stormwater Awareness

As stormwater flows over driveways, lawns, and sidewalks, it picks up debris, chemicals, dirt, and other pollutants. Stormwater can flow into a storm sewer system or directly to surface water. Here are some tips that will help keep our waterbodies clean:

- 1. Never dump, blow, or put anything into a storm drain/ditch.
- 2. Always clean up after your pet.
- 3. Put litter in the trash. Reduce, reuse, recycle.
- Use pesticides/fertilizers very sparingly.
- 5. Install native plants; they are drought, disease, and pest-resistant.
- 6. Keep yardwaste out of the street, storm drain and ditch.
- 7. Prevent soil from washing away.
- 8. Properly dispose of hazardous household chemicals (i.e., paint).
- 9. Repair vehicle leaks immediately and recycle used vehicle fluids.
- 10. Wash cars on the grass or at a commercial car wash.
