

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, ILLINOIS HELD IN THE VILLAGE BOARD ROOM ON JULY 1, 2014

<u>CALL TO ORDER</u>: President John Schmitt brought the regular meeting to order at 7:30 p.m. and requested a roll call by Village Clerk Jerry Kautz.

ROLL CALL: Present: Trustees Jerry Glogowski, Jim Steigert, Brian Dianis, John Spella, Robert Smith, Debby Sosine. A quorum was established. Staff in attendance: Tim Schloneger, Village Manager; Russ Farnum, Community Development Director; Bob Mitchard, Public Works Director; John Bucci, Deputy Police Chief; Jeanna Ballard, Administrative Intern. Attorney Kelly Cahill was also in attendance.

PLEDGE TO FLAG: Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Glogowski, to adopt tonight's agenda, deleting Item 15, Executive Session. Voice vote: ayes carried.

AUDIENCE PARTICIPATION:

- 1. Jennifer Mathis, 3600 Persimmon, Algonquin, voiced concern regarding Wood Park. She stated that if the village just places soil and seeding where the walk currently is located it would be a waste of money as the area would be washed away and then be mud after a few rain storms. She added the park is used by many residents, not just those who live on the perimeter. Access to this path is a safety issue as more adults and parents are likely to take their children to play where they can keep an eye on them. She asked the Board to try and find funds that may be available for this project.
- 2. Donna Nardulli, 3751 Persimmon, Algonquin, said she concurs with Ms. Mathis and that she is a homeowner of a premium-priced lot on the pond. Ms. Nardulli also asked the Board to please work on budgeting funds for the park. She added the village should consider gravel for the path instead of soil and seed.
- 3. Steve Shafer, 3700 Persimmon, Algonquin, asked why place soil and seed that would only last a couple of years when used ground asphalt might be a better solution.

President Schmitt responded to all comments as follows: There was some talk among Terrace Lakes Subdivision homeowners that they did not have sidewalks and that the park paths were very important. Mr. Schmitt continued that the residents did not want sidewalks when the subdivision was developed due to added costs which are built into the price of homes by the builder. If sidewalks are now wanted, the costs would have to be paid by the current homeowners through the creation of a Special Tax Services Area. As for the pond walk path reconstruction, to do the job correctly would be very expensive as the land around the pond is silt and very soggy. Just placing gravel or ground asphalt would do no good as there needs to be proper footing for a path to be built to standards. As previously stated, there are no budgeted funds at this time for Wood Park, and, due to the very harsh winter, there are many other priorities that need to be addressed at present. Park funds come from developer fees, and, as everyone knows, development has been very low these past several years. Staff will do everything possible to find other sources of revenue to help fund park projects with possible grants and other revenue, but there are no monies available at this time. So the path will not be done this year but, when it is reconstructed, it will be finished correctly and up to standards. (The Village Board states for the record that a promise is made to the residents of Terrace Lakes that the Wood Park Path project will be completed as soon as sufficient future funding can be obtained.)
