

# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON JULY 1, 2008

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 8:05 PM. Village Clerk Jerry Kautz called the roll.

# **VILLAGE MANAGER** ~ Mr. Ganek reported the following:

1 – There will be an Ash Borer bulletin with a response plan forthcoming. The insect was found on the east side of the village and McHenry County in general has been on a quarantine list. Mr. Ganek stated that 25% of all village parkway trees are ash and that the devastation could be within a five year period.

# **PUBLIC WORKS DIRECTOR** ~ Mr. Mitchard reported the following:

1 – Wastewater Treatment Plant update; he toured the site today and the work is coming along nicely. Final grading should be finished next week. 2 – Spella Park improvements are look very good. 3 – Summer asphalt and grinding is underway. 4 – A new mechanic has been added to staff. 5 – As of June 26 the village water status is under yellow restrictions. 6 – The GIS upgrading is underway. 7 – Staff is preparing for Founders Days Festival later this month.

# **COMMUNITY DEVELOPMENT** ~ Ms. Parkhurst reported the following:

1 – She thanked Mr. Mihelich for all his years of service to the village and wishes him well on his new position in Arizona. 2 – Conservation Day was very successful with both more visitors and vendors participating. 3 – The Randall Road Pedestrian Crossing study is beginning soon. 4 - Staff did an on site inspection of the Brunswick Zone on Randall Road to see what improvements were made to reduce noise from the building. There should be improvement for the future. 6 – The Planning & Zoning Commission will meet next week to discuss a planned retail and fitness center on the east side, and Advantage Movers building expansion plan.
