The Petitioner has applied for a Certificate Of Appropriateness to remove the existing rear porch and construct a replacement screened porch and deck off the rear of the house located at 39 Center St. The present porch is unstable and Petitioner proposes to replace it with a new rear deck and screened porch. Deck, railings, and porch supports will be built with treated wood. A double door will be centered on the north side of the enclosed porch providing access out onto the open deck. The screened porch will feature a gabled roofline consistent with the home's general front gable design. The roof above the screened porch will include shingles that match those of the house. This construction will be painted white.

Staff feels this request is reasonable since these improvements will be located to the rear of the house and therefore approves the Petitioner's request.

The Commission is in agreement with staff's recommendation. It is felt this design will be very complimentary to the home. It is assumed that this construction will comply with all applicable zoning codes.

Member Nee moved to recommend approval for the request of a Certificate Of Approval for the removal and replacement of a deck and screened porch on the rear of the home located 39 Center Street Case No. PC08-05 with the understanding that this construction shall be painted and that Petitioner shall comply with all applicable codes.
