

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, ILLINOIS, HELD IN THE VILLAGE BOARD ROOM ON JUNE 16, 2015

CALL TO ORDER: President Schmitt tonight's meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll with Trustees Robert Smith, Brian Dianis, Jerrold Glogowski, Jim Steigert, Robert Smith, John Spella, and Debby Sosine in attendance. A quorum was established. Staff in attendance: Tim Schloneger, Village Manager; Bob Mitchard, Public Works Director; Russ Farnum, Community Development Director; and John Bucci, Police Chief. Attorney Kelly Cahill was also in attendance.

<u>PLEDGE TO FLAG</u>: Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Glogowski, to adopt tonight's agenda, deleting Item 16, Executive Session, and moving Omnibus A1 to Discussion of Items. Voice vote: ayes carried.

<u>PRESENTATION</u>: The "Saved by the Belt" Award was presented to Anita Bartley who survived a rollover accident during winter due greatly in part to wearing her seatbelt. This is a combination IDOT and Algonquin Police award.

1. Pat Zelko, 905 Eineke, Algonquin, voiced complaint about a stop sign in her subdivision (Savannah Lane and Spella Drive) being at a place where there is absolutely nothing--no homes or structures of any kind. She would like a stop sign placed at the ends of Eineke because of speeding traffic. Chief Bucci will look into this matter.

Discussion: Trustee Smith said he will not vote for this because the State of Illinois is forcing municipalities to adhere to wage increases while villages are getting their share of tax money cut. President Schmitt stated this is a state mandate and nothing will change it. Roll call vote: voting aye – Sosine, Dianis, Glogowski, Steigert, Spella. Voting nay – Smith. Motion carried: 5-ayes, 1-nays.

<u>APPROVAL OF BILLS</u>: Moved by Dianis, seconded by Sosine, to approve the List of Bills for payment for 06/16/2015 and payroll expenses for 06/15/2015 totaling
