

# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, ILLINOIS HELD IN THE VILLAGE BOARD ROOM ON SEPTEMBER 1, 2015

<u>CALL TO ORDER</u>: President Schmitt called tonight's meeting to order at 7:30 PM. Village Clerk Jerry Kautz called the roll with Trustees Robert Smith, Brian Dianis, Jerrold Glogowski, Jim Steigert, Robert Smith, John Spella, Debby Sosine. A quorum was established.

Staff in attendance: Tim Schloneger, Russ Farnum, Michele Zimmerman, Police Chief John Bucci, and Attorney Kelly Cahill.

PLEDGE TO FLAG: Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded Glogowski, to adopt tonight's agenda, deleting Item 15, Executive Session. Voice vote: ayes carried.

(1) Thomas Gummow, 920 Harper Drive, Algonquin, complained he has been unfairly treated regarding an easement matter that begun back in 2005. He has had several confrontations with village personnel and the President over the years involving easement rights on or across his property. The village has tried to resolve the issues to no avail. President Schmitt suggested Mr. Gummow retain an attorney, so he can understand the legalities of this issue. Mr. Gummow was not pleased and abruptly left the boardroom.
