<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 8:08 PM. Village Clerk Jerry Kautz called the roll.

# **COMMITTEE & CLERK'S REPORTS:**

<u>COMMITTEE OF THE WHOLE</u> ~ Trustee Spella reported the Committee met October 14 with minutes now on file at Village Hall. Items on tonight's Omnibus were discussed at the meeting. No further Board action is required at this time.

<u>VILLAGE CLERK</u> ~ Clerk Jerry Kautz announced upcoming scheduled Village meetings. He also announced that candidate packets will be available for next April's municipal election this Friday, October 24.

#### **STAFF REPORTS**:

#### **VILLAGE MANAGER** ~ Mr. Bill Ganek reported the following:

1 – The State has allotted 3 million dollars for the next phase of the Western Bypass. Acquisition of property will take place simultaneously. 2 – Pleased to report day-to-day cost savings by the Village regarding fleets: hybrid vehicles save \$5,300 a year; squad cars going from V-8 to V-6 save over \$35K a year; bio-diesel saves 7 to \$8K per year. 3 – For the 5<sup>th</sup> year in a row, the Village has received the Budget Document Presentation Award. He singled out Jenna Kollings and Jack Walde for their efforts. 4 – He was also pleased to report that the Village 's Standard & Poor's bond ratings have been increased from AA to AA+ which is very difficult to obtain. The Village fiscally conservation financial planning has helped immensely.

#### **PUBLIC WORKS** ~ Mr. Bob Mitchard reported the following:

- 1 The Route 62 water main will be pressure tested this week. 2 Fall tree planting is going full strength. 3 The hydrant flushing program is wrapping up. 4 There will be a public meeting to discuss the Arrowhead construction schedule and plans.
- 5 The Huntington Wall reconstruction work is progressing.

#### **ASSISTANT VILLAGE MANAGER** ~ Ms. Jenna Kollings reported the following:

- 1 The free leaf pick-up is underway. 2 New software for billing is being installed.
- 3 Attachments are being made to the web site regarding the new Traffic Light Enforcement program and adjudication procedures.

#### **COMMUNITY DEVELOPMENT** ~ Mr. Craig Arps reported the following:

- 1 This year's Public Arts kickoff will be Wednesday, October 29; all are invited.
- 2 -- Toys-R-Us will have their grand opening this Thursday morning. 3 Several new businesses have picked up building permits, including Binny's Liquors.

# **POLICE DEPARTMENT** ~ Chief Laine reported the following:

1 – The recent liquor enforcement decisions have been delivered. 2 – The department has been involved with crime prevention training at local schools with help from the Police Explorers.

## **VILLAGE ATTORNEY** ~ Ms. Kelly Cahill reported the following:

1 – Her staff has been involved with code revisions, property issues, and liquor-related items.
