

MINUTES OF THE REGULAR MEETING

OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, ILLINOIS HELD IN THE VILLAGE BOARD ROOM ON APRIL 5, 2016

<u>CALL TO ORDER</u>: President John Schmitt brought the regular meeting to order at 7:30 p.m. and requested a roll call by Deputy Village Clerk Michelle Weber.

<u>ROLL CALL</u>: Present: Trustees Jim Steigert, Debby Sosine, John Spella, Jerry Glogowski and Brian Dianis. Absent: Robert Smith. A quorum was established. Staff in attendance: Tim Schloneger, Village Manager; Russ Farnum, Community Development Director; Bob Mitchard, Public Works Director; Jeff Sutrick, Deputy Police Chief. Attorney Kelly Cahill was also in attendance.

<u>PLEDGE TO FLAG</u>: Deputy Village Clerk Weber led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Glogowski, seconded by Dianis, to adopt tonight's agenda, deleting Item 16, Executive Session. Voice vote: ayes carried.

AUDIENCE PARTICIPATION:

Mr. Don Purn asked the Board if the Historic Commission would be able to put a tent on the lot adjacent to Historic Village Hall during the Founder's Days Car Show. He would like to show off their Hill Climb memorabilia. President Schmitt indicated he doesn't see any reason why this would be a problem and he should contact Diane LaCalamita regarding required permits.

Mr. Tom Gummow, 920 Harper Drive, expressed concerns about the drainage culvert, bridge and debris on and adjacent to his property. Village staff and officials reiterated that a revised plat of survey remains ready for his signature.

<u>ADMINISTRATION</u> ~ Mr. Schloneger reported:

- Finance staff met with our new auditors from Sikich and will be beginning preliminary audit work over the next few weeks.
- With the approval of the budget, staff will finalize the budget document and have a printed copy available for the Board at their annual meeting in May.
- The summer Recreation Guide is available online and registration is now open. Printed copies will be delivered to Algonquin households next week.
- Free leaf and brush collection from Groot will occur this week and next on resident's normal collection day.
- The Spring Cleanup dates for the Village will be April 16 and April 23.

<u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported:

- Public Art Program Student Art Show runs through April 20 at the Main Library, student artist
 reception was last night, very nice. Artist submittals done for Public Art Program this year,
 beginning to jury the submittals, will share with Board once finalists selected.
- Working closely with Buena Beef and 2 Dunkin Donuts sites to get them going soon. All are
 on the cusp of breaking ground.
- Nordstrom is underway in the Commons.
- Art Van is open, their ribbon cutting is this Saturday, April 9, at 8:45 am.
- Trustee Steigert and Ben Mason are front page material.

• The number of permits was down this past month, but fees and value were both substantially higher and we are 20% up on new housing starts over last year.

Mr. Spella asked if the Arts Commission is planning anything like the 2015 art program, Ship Set Sail? Mr. Farnum indicated there was not a plan for that this year. This year there are many new art submissions that will be displayed throughout the Village.
