



Minutes of the Village of Algonquin
Special Liquor Commission Meeting
Held in Village Board Room on August 16, 2016

CALL TO ORDER: Liquor Commissioner John Schmitt called the meeting to order at 7:15 pm and requested Village Clerk Jerry Kautz to call the roll. Present: Brian Dianis, Jim Steigert, Jerrold Glogowski, John Spella, Debby Sosine, Bob Smith. (Quorum established)
Staff in attendance: Tim Schloneger, Bob Mitchard, Deputy Chief Sutrick. Village Attorney Kelly Cahill was also present.

1. Approve a Special Event Liquor License for St. Margaret Mary's Summerfest 2016

St. Margaret Mary Church, 119 S. Hubbard Street, Algonquin, will be holding their annual "Summerfest" on Sunday, August 28, 2016 from 12:00 PM – 8:00 PM. They are requesting a Special Event Liquor Permit to serve Beer and Wine during their event in a designated area. St. Margaret Mary Church has complied with the village's requirements by completing the submittal of all documents and fees as required by the Village of Algonquin for obtaining the license pertinent to their establishment. All fees have been paid and all documents are in order. Consensus of the Commissioners was to allow this permit issuance.

2. Approve an A-1 Liquor License for Awesome Sauce, Inc. d/b/a Buddy Z's Pizza, 2749 West Algonquin Road, Algonquin

The business is being taken over by a new entity beginning August 23, 2016. This license is only for the period ending April 30, 2017; it will then be renewed for the next fiscal year. Awesome Sauce Inc. d/b/a Buddy Z's Pizza, has complied with the village's requirements by completing the submittal of all documents and fees as required by the Village of Algonquin for obtaining the license pertinent to their establishment. All fees have been paid and all documents are in order.

Upon the approval and issuance of the Liquor License for Awesome Sauce Inc. d/b/a Buddy Z's Pizza, and the termination of the license for the previous owners, ITSA-Good Enterprises, Inc. this class will have no licenses available.

Consensus of the Commissioners was to allow this License issuance.

3. Approve an A-1 Liquor License for Thai Chilli & Sushi Inc. d/b/a Bangkok, 4077 West Algonquin Road, Algonquin

Thai Chilli & Sushi Inc. d/b/a Bangkok, 4077 W. Algonquin Road, Algonquin, would like to reinstate their A-1 liquor license. At the time their liquor license was up for renewal, April 30th, the corporation was not registered with the state with the proper owner. Since that time, all changes have been made with the state and appropriate agencies. They have complied with the village's requirements by completing the submittal of all documents and fees as required by the Village of Algonquin for obtaining the license pertinent to their establishment. All fees have been paid and all documents are in order.

Consensus of the Commissioners was to allow this License issuance.

4. Approve an A-1 Liquor License for Algonquin Operations LLC d/b/a Clarendale of Algonquin, 2001 West Algonquin Road, Algonquin

Algonquin Operations LLC d/b/a Clarendale of Algonquin, 2001 W. Algonquin Road, Algonquin would like to be able to sell/serve alcohol on the premises for consumption on the premises (A-

1) in their on-site Pub and Restaurant. They have complied with the village's requirements by completing the submittal of all documents and fees as required by the Village of Algonquin for obtaining the license pertinent to their establishment. All fees have been paid and all documents are in order. Liquor will only be available to residents and their guests. There will be no walk in business.

Consensus of the Commissioners was to allow this License issuance.

5. Approve a B-2 Liquor License for OM Ganshay, Inc. d/b/a 7-Eleven Store #33784, 501 East Algonquin Road, Algonquin

OM Ganshay, Inc. d/b/a 7-Eleven Store #33784, 501 E. Algonquin Road, Algonquin currently holds an E license (sell beer and wine) and would like to change their license to be able to sell all alcohol (B-2) for consumption off premises. Upon approval of the B-2 Liquor License their Class E liquor license will be relinquished. They have complied with the village's requirements by completing the submittal of all documents and fees as required by the Village of Algonquin for obtaining the license pertinent to their establishment. All fees have been paid and all documents are in order.

Consensus of the Commissioners was to allow this License issuance.
