

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON MAY 19, 2009

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

ROLL CALL: Present: Trustees Robert Smith, Jerry Glogowski, Deborah Sosine, Brian Dianis, Jim Steigert. Absent: John Spella. A quorum was established. Staff in attendance: Administration – William Ganek, Michele Zimmerman, Jenna Kollings, Craig Arps. Police – Russ Laine. Attorney – Kelly Cahill.

PLEDGE TO FLAG: Village Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Sosine, to adopt tonight's agenda deleting Item 15, Executive Session. Voice vote; ayes carried.

AUDIENCE PARTICIPATION:

1. Patricia Zelko, 905 Eineke Blvd., Algonquin, voiced concern that the traffic on Eineke has not been reduced, as stated by the Village, since the J C Penney's frontage road was opened. President Schmitt said he too was disappointed in lack of reduction but the Village cannot close the road. Traffic enforcement is still taking place so it is not a safety issue but one of volume.

Due to extremely wet weather, the park playground preparation is now underway. Also, fire hydrant flushing and videoing water mains are taking place.

ASST. VILLAGE MANAGER ~ Ms. Kollings reported the following:

She thanked the Board for participating in the recreational evaluation study earlier this evening. In other items, the Municipal Pool is being readied for the summer season, and a Residents' Assistance Guide for those in hardship is now available for viewing on the Village web site as the web pages are being expanded. Staff is promoting the GIS system online at local schools. The Village will sponsor an E-Waste Recycling Day on August 1, 9 AM to Noon at the Public Works Facility with details on the web site.

COMMUNITY DEVELOPMENT ~ Mr. Arps reported the following:

Martini's on Main will reopen under new ownership on May 29. Other happenings are Relax Furniture will open soon in the former Wickes building, Wal-Mart will open its grocery section on July 1, a new ice cream parlor will be coming to Algonquin soon, the annual Art in the Park will be June 6, and Woods Creek Conservation Day will be conducted on June 19.

POLICE DEPARTMENT ~ Chief Laine reported the following:

Memorial festivities will begin at 10 AM at the cemetery, with a parade afterward to Riverfront Park at 10:30. In other news, Target Store donated a community policing grant of \$1,300 to the Police Department for their Bike Patrol. Some of our officers will offer training in combating domestic violence to nurses who will specialize in those areas.
