<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 8:05 PM. Village Clerk Jerry Kautz called the roll.

STAFF REPORTS:

VILLAGE MANAGER ~ Mr. Ganek reported the following:

He has been working on gathering information regarding transportation projects including the Western bypass.

PUBLIC WORKS ~ Mr. Mitchard reported the following:

The Hanson Road water tower painting should be completed close to June 26th. The Village is ready for a final payout of the wastewater treatment plant project. Spring tree planting continues this week. A report on the Emerald Ash Borer was distributed tonight. Thirty-eight trees were removed in 2008 with 11 ash trees removed so far this year. There is general infestation in the entire community. Thirty-eight percent of all parkway trees in the Village are ash. Road resurfacing continues at Randall Road.

<u>ASST. VILLAGE MANAGER</u> ~ Ms. Kollings reported the following:

The results of the Recreation Study Focus Group are being prepared. The Municipal Pool has been prepared and will open this Sunday. Ms. Kollings, along with other staff members, has completed training for emergency response.

COMMUNITY DEVELOPMENT ~ Mr. Farnum reported the following:

Development continues with the openings soon of the Wal-Mart addition, Cardinal Fitness on the east side of town, and Discovery Clothing in the Commons. The Farmers' Market opens this Thursday in the downtown area; the second annual fine art show will be held on Saturday at Riverfront Park; and the annual Community Conservation Day will be held June 19th on the Woods Creek Bike Trail with everyone welcome.

POLICE DEPARTMENT ~ Chief Laine reported the following:

Video recording equipment is being installed in the interview room for the protection of all involved. The funding is due in part from various grants. D.A.R.E. graduation is scheduled for Eastview School on June 11th. Our Department will be participating, for the twentieth year, in the Special Olympics Torch Run on June 7th beginning 7:30 AM.

VILLAGE ATTORNEY ~ Ms. Cahill reported the following:

<u>OLD BUSINESS</u>: Mr. Mitchard responded to a question from Mr. Smith asking when Yellowstone Park will be completed. The reply was the final playground equipment and play surface mulch have been installed. The path that connects the park to the roadway and turf restoration have been held up because of inclement weather. This work should be completed by the third week in June. Mr. Mitchard also stated that Village street and road safety repairs have taken up a great amount of staff's time due to the wet weather conditions.
