

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON JULY 7, 2009

CALL TO ORDER: Village President John Schmitt brought the regular meeting to order at

8:00 p.m. Village Clerk Jerry Kautz called the roll.

PUBLIC WORKS ~ Mr. Mitchard reported the following:

Work on Arrowhead Subdivision continues on budget. Curbs are being replaced at this time and water mains later this week with paving to follow. Square Barn, Hanson Road, Bunker Hill, and Huntington Drive work will begin with materials being ordered. Some of the work will be at night to alleviate traffic problems. There will be some lane closures but no road blockage. The Hanson Water Tower painting is nearing completion, and the Hanson Road Section 7 project contract is waiting for IDOT to approve bids.

At this point, Trustee Glogowski recused himself from the room as the first item could possibly be perceived as a conflict of interest.

With the President and remaining trustees seated, Attorney Cahill reported that the Board discussed two matters being probable litigation and a personnel collective bargaining agreement. The following Board action is required at this time:

1. Moved by Sosine, seconded by Steigert, to approve a Settlement Agreement and Release with Siemens Water Technologies and Kovilic Construction Company regarding Water Treatment Plant #3.

Roll call vote: voting aye – Sosine, Dianis, Spella, Steigert, Smith. Motion carried: 5-ayes, 0-nays, 1-absent.

At this point Trustee Glogowski was reseated at 8:47 p.m.

2. Moved by Smith, seconded by Glogowski, to approve the Collective Bargaining Agreement with the Metropolitan Alliance of Police Local 78. Roll call vote: voting aye – Smith, Glogowski, Sosine, Dianis, Spella, Steigert. Motion carried: 6-ayes, 0-nays.

<u>ADJOURNMENT</u>: There being no further business, it was moved by Glogowski, seconded by Sosine, to adjourn. Voice vote: ayes carried.
