

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON SEPTEMBER 15, 2009

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 8:15 PM. Village Clerk Jerry Kautz called the roll.

STAFF REPORTS:

ASST. VILLAGE MANAGER ~ Ms. Kollings reported the following:

A reminder that the Waste Management route schedule will change on October 5. A flyer with the new routes is being distributed. Homeowners affected by the change will receive postcards. The Village of Algonquin, in partnership with the Environmental Defenders of McHenry County, is sponsoring the second annual "It's Our River Day" celebration. The event will be held on Saturday, September 19, 2009, from 1:00pm-4:00pm, at Cornish Park in downtown Algonquin. The recent Freedom of Information Act changes will be discussed at a future Committee of the Whole meeting. As of January 1, 2012, landfills will no longer be accepting electronic products. Staff is studying this new state legislation on how it will affect our residents. The Village staff's ECO Committee Environmental Action Plan is progressing.

<u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported the following:

Staff is dealing with property maintenance issues on land near the Route 62 bridge on the east bank of the river. Violations have been issued. The Village is in the process of working with residents on enforcing the "gravel driveway to paved driveway" matter. Some property owners are electing to convert to grass on the particular area. Any calls from residents regarding this issue should be directed to Community Development staff.

PUBLIC WORKS ~ Ms. Zimmerman reported the following:

Hanson Road reconstruction is underway and on schedule with tree removal and utility work now completed, and curbs being installed at this time. his Monday, the Village will begin resurfacing Huntington from Briarwood to Hanson Road. Funds for this project come from the federal "stimulus" package. Fall tree trimming has also to begin.

<u>POLICE DEPARTMENT</u> ~ Chief Laine reported the following:

The International Chiefs of Police Association just completed a study and seminar on "Violence against Women." Sergeant Wisnauski represented our department at the meeting. Sergeant Jeff Sutrick is graduating from the FBI Academy next Friday. Staff is currently working on various traffic studies.
