



**MINUTES OF THE REGULAR MEETING  
OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF  
ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON  
APRIL 4, 2006**

**CALL TO ORDER:** Village President John Schmitt brought the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

**ROLL CALL:** Present: Trustees John Spella, Robert Smith, Jerrold Glogowski, Jim Steigert, Brian Dianis, Barbara Read. A quorum was established.

**PLEDGE TO FLAG:** Village Clerk Kautz led all present in the Pledge of Allegiance.

**ADOPT AGENDA:** Moved by Smith, seconded by Dianis, to adopt tonight’s agenda as printed including item 16, Executive Session. Voice vote; ayes carried.

**ADMINISTER OATH:** Clerk Kautz administered the Oath of Office to Trevor Vogel as a new Police Officer, and welcomed him to the Village.

**VILLAGE MANAGER** ~ Mr. Ganek reported the following:

The Village has received the "Tree City USA" award for the 10<sup>th</sup> year. Thanks goes to the Parks & Forestry Department for a job well done.

**PUBLIC WORKS DIRECTOR** ~ Mr. Mitchard reported the following:

Water Treatment Plant 3 has been up and running for a month with a few minor issues. The contractor is working to resolve the problems. A formal ribbon cutting is planned for the near future when the weather gets better. Well # 13 has had some failures in the electrical supply cable. Repairs are ongoing. The Wastewater Treatment Plant review has ended by the EPA, and now waiting for the construction permit. Winter tree trimming has ended and Spring operations are beginning.

**COMMUNITY PLANNING DIRECTOR** ~ In the absence of Mr. Mihelich, Mr. Arps reported the following:

The Department is working on a marketing strategy plan for the Corporate Campus. The Planning & Zoning Commission will be discussing plans for new buildings in the Esplanade. Ethan Allen Furniture has now picked up its building permit for the Galleria Center.

**VILLAGE ENGINEER** ~ Mr. Cuda reported the following:

Well 13 power drops will be repaired tomorrow. The new pump station will be in operation soon. The permanent traffic lights at Harrison and Algonquin Road will also be installed very soon.

**POLICE DEPARTMENT** ~ Chief Laine reported the following:

One new officer is in training at this time, with two more hires scheduled for this month.

**VILLAGE ATTORNEY** ~ Ms. Cahill reported the following:

Her staff has been involved with liquor matters, and she will reserve her other comments for the executive session to follow involving litigation.

**Moved by Glogowski, seconded by Smith, to approve the settlement agreement and release in the case of Michael Nelson and David Heuer, individually and on behalf of all persons similarly situated versus the Village of Algonquin, et al, Case #05CH283 with provision of spot check being added.**

**Roll call vote; voting aye -- Glogowski, Dianis, Steigert, Read, Spella, Smith.  
Motion carried; 6-ayes, 0-nays.**
