

# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON APRIL 6, 2010

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 8:01 PM. Village Clerk Jerry Kautz called the roll.

<u>ROLL CALL</u>: Present: Trustees Robert Smith, Jerry Glogowski, Deborah Sosine, Brian Dianis, John Spella, Jim Steigert. A quorum was established. Staff in attendance: Administration - Bill Ganek, Russ Farnum, Bob Mitchard.

<u>PLEDGE TO FLAG</u>: Boy Scouts from Troop #368 in Algonquin led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Smith, seconded by Dianis, to adopt tonight's agenda, deleting Item 16, Executive Session. Voice vote: ayes carried.

<u>PRESENTATION</u>: Representatives from Elgin Community College gave an update on new health career curricula and learning centers.

Ms. Susan Van Weelden, Director of Community Engagement and Economic Development, and Dr. Donna Redmer, ECC Trustee, gave an overview of new programs offered by the college; they also named several prominent alumni from Algonquin who excelled in academics and sports. They spoke about the new Health Career Center and Academic Library, as well as the new outreach locations in the Algonquin area. When the presentation ended, Dr. Redmer stated the ECC Board of Trustees just approved additional parking to serve these new facilities.

<u>COMMITTEE OF THE WHOLE</u> ~ Trustee Glogowski reported the Committee met earlier tonight with minutes forthcoming. Items discussed at that meeting were on tonight's Omnibus agenda with the following items requiring Board action at this time:

## Under Public Works & Safety

1. Moved by Glogowski, seconded by Smith, to accept the bid and award the contract for Algonquin Hills Phase 4, North Harrison Street Improvements to Curran Contracting in the amount of \$1,253,322.30.

Roll call vote: voting aye – Glogowski, Sosine, Dianis, Spella, Steigert, Smith. Motion carried: 6-ayes, 0-nays.

- 2. Moved by Glogowski, seconded by Dianis, to accept the bid and award the contract for Bar Screening Equipment for the Wastewater Treatment Plant to Environmental Resources, Inc. of Pewaukee, Wisconsin in the amount of \$50,874.00.
- Roll call vote: voting aye Glogowski, Sosine, Dianis, Spella, Steigert, Smith. Motion carried: 6-ayes, 0-nays.
- 3. Moved by Glogowski, seconded by Sosine, to accept the bid and award the contract for Final Grading and Concrete at the Wastewater Treatment Plant to Paulson Paving in the amount of \$104,000.00.

#### VILLAGE MANAGER ~ Mr. Ganek reported the following:

1- The Village is applying to Google for its Fiber Optic Program. It could provide internet speed up to 100 times faster than present. There are several other communities, both large and small, applying for this program. 2- We are working with Lake in the Hills and Crystal Lake to obtain a grant for the Woods Creek watershed. 3- The art bike racks are now on display at the Community Development Department.

## PUBLIC WORKS ~ Mr. Mitchard reported the following

- 1- The tree trimming program is underway. 2- Staff is doing controlled burns in the Village.
- 3- Old Oak Terrace Phase 2 Road Pre-Con meeting is scheduled for April 28. 4- Hanson Road construction will restart soon. It should have begun on April 1 but ATT did not complete their utilities work on time. A firm schedule from Curran Construction is forthcoming.

## <u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported the following:

- 1- Staff is looking for field locations throughout the Village for placing the new bike racks.
- 2- The Business Visitation Program is in process. This improves communication between the Village and local businesses. 3- Staff is working on the Riverside Square matter. 4- New software is being put in place to improve Community Development files.
