

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, ILLINOIS HELD IN THE VILLAGE BOARD ROOM ON OCTOBER 16, 2018

CALL TO ORDER: President Schmitt called tonight's meeting to order at 7:30 PM.

Village Clerk Jerry Kautz called the roll with the following Trustees present; John Spella, Janis Jasper, Jerrold Glogowski, Laura Brehmer, Debby Sosine, Jim Steigert.

<u>ADOPT AGENDA</u>: Moved by Glogowski, seconded by Spella, to adopt tonight's agenda deleting item 15, Executive Session and moving Item Omnibus B-4 to Discussion. Voice vote carried.

DISCUSSION OF ITEM REMOVED FROM OMNIBUS

(1) Trustee Brehmer expressed concerns regarding the Village allowing a sales tax rebate to Rosen Hyundai that amounts to \$600K and if it would affect dealings with other businesses. Attorney Cahill assured her that this is definitely legal for municipalities to do for the benefit of all concerned. President Schmitt said that by allowing the 'temporary' tax rebate the Village can look forward to many years of addition funding for many village projects. He added that Rosen will spend millions of their money to bring a high end Genesis dealership to town. Algonquin has only given sale tax rebates to auto dealerships that create large amounts of sales taxes. After discussion he requested the following motion.

Moved by Glogowski, seconded by Spella, to adopt Resolution **2018-R-60**, approve and accept a Business Development Agreement with Rosen Hyundai Enterprises, LLC.

Roll call vote; voting aye –Sosine, Spella, Jasper, Glogowski, Steigert.

Voting nay - Brehmer.

Motion carried; 5-ayes, 1-nays.
